DELEGATION No. 40

The Environmental Protection Authority ("Authority"), acting pursuant to section 19 of the Environmental Protection Act 1986 ("the Act"), has resolved to delegate all its powers and duties conferred or imposed by—

- a. section 17(3)(b) of the Act save that these powers and duties may only be exercised in circumstances where an implementation condition provides for the Authority's advice to be given to the Minister for Environment on a matter relating to the implementation of the proposal:
- b. sections 38(5c), 38A(1), 39, 39A, 40(2)(a), 40(2)(aa), 40(2)(b), 40(2a), 40(4), 40(5), 40(6)(b), 40A, 41A, 43A, 48A, 48C, 107(1) of the Act;
- c. section 40(3) of the Act save that these powers and duties may only be exercised in circumstances where it has been decided, and set out in the public record, that the level of assessment includes a requirement for an environmental review with no public review;
- d. sections 44(1) and 44(2a) of the Act save that these powers and duties may only be exercised in circumstances where the Authority has resolved that, a person to whom this delegation applies, should prepare and approve the final report and give that report to the Minister;
- e. section 46 of the Act, including s46(4) save for exercising the discretion under s46(4) in relation to the decision as to whether or not to inquire into implementation conditions relating to proposal declared a derived proposal under s39B of the Act;
- f. section 48D (1) of the Act save that these powers and duties may only be exercised in circumstances where the Authority has resolved that, a person to whom this delegation applies, should prepare and approve the final report and give that report to the Minister.

Pursuant to section 59(2) of the *Interpretation Act 1984* the delegation of the powers referred to in the sections of the Act listed above shall be deemed to include the delegation of any duty incidental thereto or connected therewith.

Persons to whom this delegation applies—

- a. The Chairman of the Environmental Protection Authority appointed under s7(4a) of the Act;
- b. The Deputy Chairman of the Environmental Protection Authority appointed under s7(4a) of the Act on the conditions that the delegation is only exercised by the Deputy Chairman when the Chairman is unable to exercise the delegation either because of an absence (on business or leave) or due to a conflict of interest.

SPEED RESTRICTION AREA—MOTORISED VESSELS 8 Knots—Perth Waters Swan River Perth

Department of Transport, Fremantle WA. 7 March 2017.

Acting pursuant to the powers conferred by Section 67 of the Western Australian Marine Act 1982, I hereby cancel notice number MA402 published in the Government Gazette on 19 February 2016 and limit the speed of motorised vessels to eight (8) knots within the following area—

PERTH WATER: All waters of the Swan River bounded by a line commencing at 31°57.612′S, 115°51.725′E (on the foreshore approx. 220 metres east of the West Australian Rowing Club boatshed); thence to the navigation marker at 31°57.709′S, 115°51.695′E (approx. 185 metres south-south-westerly); thence along the line of the southern boundary of the navigation channel to where this intersects Heirisson Island at approximately 31°58.007′S, 115°52.611′E; thence along the western shore of Heirisson Island and the western boundary of the Western Australian Powered Water Sports Area; thence westerly along the South Perth foreshore; thence along the eastern side of the Narrows Bridge to the start of the navigation channel at approximately 31°57.835′S, 115°50.830′E; thence along the southern boundary of the Narrows Bridge to Barrack Street navigation channel to the navigation marker at 31°57.655′S, 115°51.362′E; thence easterly approximately 125 metres to the navigation marker at 31°57.625′S, 115°51.290′E; thence

northerly approximately 160 metres to where the western end of the Elizabeth Quay footbridge meets the shoreline at 31°57.539′S, 115°51.317′E; but excluding the area within and adjacent the Elizabeth Quay inlet which has been set aside as a 5 knot speed restriction area. All coordinates based on GDA 94.

This notice does not apply to seaplanes whilst taking off and landing within Perth Waters south of Riverside Drive, east of the Mends Street and north of the Coode Street navigational channels; and

This notice does not apply to all licensed commercial water ski vessel operations within Perth Waters within a radius of 340 metres from a point on the foreshore 70 metres downstream of the Queen Street Jetty, South Perth.
