STANDING ORDERS AMENDMENT LOCAL LAW 2017

Under the powers conferred by the *Local Government Act 1995* and all other powers enabling it, the Council of the City of Cockburn resolved on 9 March 2017 to make the following local law.

1. Citation

This local law may be cited as the City of Cockburn Standing Orders Amendment Local Law 2017.

2. Commencement

This local law comes into operation 14 days after the day of its publication in the $Government\ Gazette.$

3. Principal Local Law amended

This local law amends the *City of Cockburn Standing Orders Local Law 2016* as published in the *Government Gazette* on 22 September 2016.

4. Part 4 amended

(1) In clause 4.4 (3)(1), after the words 'no bad language' delete the words "argument or expression of opinion".

(2) In clause 4.6(1) after the words 'by a member' delete the words "who shall himself or herself with the contents thereof and ascertain that it does not contain language disrespectful to the local government".

City of Wanneroo

PUBLIC PLACES AND LOCAL GOVERNMENT PROPERTY AMENDMENT LOCAL LAW 2017

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Wanneroo resolved on 7 March 2017 to make the following local law.

1. Citation

This local law may be cited as the City of Wanneroo Public Places and Local Government Property Amendment Local Law 2017.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the $Government\ Gazette.$

3. Principal local law

This local law amends the *City of Wanneroo Public Places and Local Government Property Local Law 2015* as published in the *Government Gazette* on 29 February 2016. The principal local law is amended as follows.

4. Clause 1.5 amended

(a) In clause 1.5 after the definition for "authorised person" insert—

beach means the area of sandy shoreline from the low-water mark to either the toe of the dune or the commencement of vegetation or a man-made structure";

(b) In clause 1.5 after the definition for "district" insert—

dune means a mound or ridge of sand or other loose sediment, that may or may not contain vegetation that adjoins a beach";

5. Part 5, Division 3 amended

After clause 5.8 insert-

5.9: Unauthorised vehicles on beaches and dunes.

A person must not cause a vehicle to be or drive a vehicle, on a beach or dune unless otherwise authorised or approved by the local government or any other public authority.

6. Schedule 2 amended

After Clause 5.8 insert—

Clause	Description	Penalty Unit
5.9	Unauthorised vehicles on beaches and dunes	50
