## 1. Citation

This order is the Local Government (Murchison - Discontinuance of Ward System) Order 2017.

## 2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

## 3. Terms used

In this order —

*commencement day* means the day on which clause 4 comes into operation;

*next election* means the first ordinary election for the Shire of Murchison held after commencement day;

*next election day* means the day fixed for the holding of the poll for the next election.

## 4. Wards abolished

On next election day, all wards in the district of Murchison are abolished.

## 5. Consequential directions

In order to give effect to clause 4 —

- (a) Part 4 of the Act applies to preparing for and conducting the next election as if the changes effected by clause 4 take effect on commencement day; and
- (b) the operation of Part 4 of the Act is modified to the extent necessary for the purposes of paragraph (a).

## 2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

## 3. Terms used

In this order —

Authority has the meaning given in section 9.69(1) of the Act;

*commencement day* means the day on which clause 4 comes into operation;

*Deposited Plan*, followed by a number, means the deposited plan of that number —

- (a) lodged with the Authority; and
- (b) certified by an authorised land officer, as defined in section 9.69(1) of the Act; and

- (c) available
  - (i) in paper form at the Authority's head office; and
  - (ii) in electronic form on the Authority's official website;

*next election* means the first ordinary election for the Shire of Mundaring held after commencement day;

*next election day* means the day fixed for the holding of the poll for the next election.

## 4. Ward boundaries changed

- (1) On next election day, the boundaries of the Central Ward in the district of Mundaring are changed so that the ward consists of the land delineated in red and coloured pink on Deposited Plan 410038 version 1.
- (2) On next election day, the boundaries of the South Ward in the district of Mundaring are changed so that the ward consists of the land delineated in red and coloured green on Deposited Plan 410038 version 1.
- (3) On next election day, the boundaries of the West Ward in the district of Mundaring are changed so that the ward consists of the land delineated in red and coloured blue on Deposited Plan 410038 version 1.

  - 'planning approval' replace with 'development approval'.
  - 'Council' replaced with 'local government'.
  - 'Residential Design Codes' replaced with 'R-Codes'; and
  - 'Scheme reserves' replaced with 'local reserves'.
- c. Amending sub-clause 1.2.1 to read as follows-
  - 1.2.1 The Shire of Cocos (Keeling) Islands is the local government responsible for the enforcement and implementation of this Scheme and the execution of any works required to be executed under this scheme.

The Scheme comprises—

- (a) This Scheme Text.

- 7.1.3 Notwithstanding any existing assessment on record, the local government may require a heritage assessment to be carried out prior to the approval of any development proposal affecting a place listed under Schedule 5 of this Scheme.
- o. Inserting a new 'Schedule A—Supplemental Provisions' after sub-clause 11.6.2 and before Schedule 1, and include the following provisions into the new 'Schedule A'.

#### SCHEDULE A—SUPPLEMENTAL PROVISIONS

These provisions are to be read in conjunction with the deemed provisions (Schedule 2) contained in the *Planning and Development (Local Planning Schemes) Regulations 2015 (WA)(CKI).* 

Clause 61 (1)—
