Road Traffic Act 1974

Road Traffic (Self-testing Breath Analysis Apparatus) Notice 2017

Made by the Minister for Police under the *Road Traffic Act 1974* section 72(2)(a) and (2a).

1. Citation

This notice is the *Road Traffic (Self-testing Breath Analysis Apparatus) Notice 2017.*

2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice on the day after that day.

3. Approval and designation of apparatus

- (1) Under section 72(2)(a) of the Act, apparatus of the type known as the "Dräger Alcotest 9510" is approved for the purpose of ascertaining a person's blood alcohol content by analysis of a sample of the person's breath.
- (2) Under section 72(2a) of the Act, apparatus of the type approved under subclause (1) is designated as self-testing apparatus.

Road Traffic Act 1974

Road Traffic Code Amendment Regulations (No. 3) 2017

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Road Traffic Code Amendment Regulations (No. 3) 2017.*

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette* (*gazettal day*);
- (b) the rest of the regulations on the day after the period of 8 weeks beginning on gazettal day.

3. Regulations amended

These regulations amend the Road Traffic Code 2000.

4. Regulation 3 amended

(1) In regulation 3(1) insert in alphabetical order:

speed limit, applicable to —

- (a) a heavy vehicle speed zone, means the speed indicated by the numerals on the "heavy vehicle speed zone" sign at the beginning of the zone;
- (b) a school zone, means the speed indicated by the numerals on the "school zone" sign at the beginning of the zone;
- (c) a speed limited area, means the speed indicated by the numerals on the "area speed limit" sign on a road leading into the area;
- (d) a speed zone, means the speed indicated by the numerals on the speed limit sign, at the beginning of the zone;

- (2) After regulation 3(1) insert:
 - (2) For the purposes of these regulations, a reference to speed is a reference to speed measured in kilometres per hour.

5. Regulation 11 amended

(1) In regulation 11(3) delete "exceeding, in kilometres per hour, that indicated by the numerals on the speed limit sign, at the beginning of the speed zone." and insert:

exceeding the speed limit applicable to the zone.

(2) In regulation 11(5) delete "exceeding, in kilometres per hour, that indicated by the numerals on the "area speed limit" sign erected on a road leading into that area." and insert:

exceeding the speed limit applicable to the area.

- (3) In regulation 11(6):
 - (a) in paragraph (a) delete "exceeding, in kilometres per hour, that indicated by the numerals on; and" and insert:

exceeding the speed limit applicable to the zone; and

- (b) delete paragraph (b) and the passage that begins "the "school zone" sign" and continues to the end of the regulation and insert:
 - (b) during the school zone periods indicated on the "school zone" sign at the beginning of the zone.

6. Regulation 12 amended

In regulation 12 delete "speed limit unless —" and insert:

speed limit applicable to the zone unless —

7. Regulation 14 amended

In regulation 14 delete "indicated by numbers shown on the "heavy vehicle speed zone" sign." and insert:

applicable to the zone.

8. Regulation 16 amended

In regulation 16 delete "in kilometres per hour".

9. Regulation 18A inserted

At the end of Part 3 insert:

18A. Evasive action in relation to speed camera

(1) In this regulation —

average speed detection system has the meaning given in the Road Traffic (Administration) Act 2008 section 117B(1);

speed measuring and recording equipment has the meaning given in the Road Traffic (Administration) Act 2008 section 117(1).

(2) A person must not drive a motor vehicle on a road if the vehicle is fitted with any device or other equipment that would prevent or adversely affect the operation of speed measuring and recording equipment or an average speed detection system.

Points:

- (a) during a holiday period: 14
- (b) other than during a holiday period: 7

Modified penalty:

- (a) when driving a heavy vehicle: 30 PU
- (b) when driving a motor vehicle other than a heavy vehicle: 24 PU
- (3) A person must not drive a motor vehicle on a road in a manner that would prevent or adversely affect the operation of speed measuring and recording equipment or an average speed detection system.

Points:

- (a) during a holiday period: 14
- (b) other than during a holiday period: 7

Modified penalty:

- (a) when driving a heavy vehicle: 30 PU
- (b) when driving a motor vehicle other than a heavy vehicle: 24 PU
- (4) A person who commits an offence against regulation 109, 112, 116, 117 or 129 (a road positioning offence) is taken to have also committed an offence against subregulation (3) if the road positioning offence is committed within 100 m of
 - (a) speed measuring and recording equipment; or

(b) the detection points, as defined in the *Road**Traffic (Administration) Act 2008

section 117B(1), for an average speed detection system.

BUSH FIRES ACT 1954

City of South Perth 2017/2018 FIREBREAK NOTICE

All Owners and/or Occupiers of Land within the City of South Perth

As a measure for preventing the outbreak of a bush fire, or for preventing the spread or extension of a bush fire which may occur, all owners and occupiers of land within the City's district are required before 1 December 2017 to clear firebreaks or to take measures in accordance with this Notice and maintain those firebreaks and measures in accordance with this Notice up to and including 30 April 2018.

1. All land which is 2000 m² or less in area

Remove all inflammable matter from the whole of the land, except living trees, shrubs, plants and lawns under cultivation, by means of ploughing, cultivating or slashing to a height of no more than 50mm across the entire property. Where the area is 2,000 square metres or less, clear the land free of all inflammable matter, except for living trees, shrubs, plants and lawns under cultivation, to a height no greater than 50mm.

2. All other land within the City of South Perth

- I. Clear bare earth 3 metre wide firebreaks immediately inside all external boundaries of the land by removing all inflammable matter and vegetation within the 3 metre wide firebreak between the ground and 4 metres above the ground.
- II. Firebreaks to a minimum width of 3 metres and height of 4 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept;
- III. In addition to the requirements in this clause Council may, by notice in writing require an owner and/or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of Council is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

If, for any reason, an owner and/or occupier consider it impractical to clear the land or comply with other fire protection measures in accordance with the notice, the owner and/or occupier may apply in writing to the City no later than the 31st day of October in any year for a variation. If permission is not granted in writing by the City or its authorised officer, the owner and/or occupier must comply with the requirements of this notice. Any variation granted by the City will apply only for a single Firebreak Period. A variation granted by the City shall only remain in force until the 30th day of April in the following year.

In addition to the requirements in this notice the City may, by notice in writing require an owner and/or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of the City is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

The term Inflammable matter for the purpose of this notice includes bush (as defined in the *Bush Fires Act 1954*), timber, boxes, cartons, paper, rubbish and any other combustible or inflammable matter.

Penalty for Non Compliance

A person who fails to comply with the requisitions in this notice is guilty of an offence and liable to a penalty of \$5,000. In addition, where the owner or occupier of the land fails to comply with a notice given pursuant to section 33(1) of the *Bush Fires Act 1954*, the City may enter upon the land and carry out the requisitions of the notice which have not been complied with and the City may recover the amount of any costs and expenses incurred in carrying out those requisitions as a debt due from the owner or occupier of the land maintained clear of inflammable matter up to and including 30 April in the following year.
