Electricity Act 1945

# Electricity (Licensing) Amendment Regulations (No. 2) 2017

Made by the Governor in Executive Council.

### 1. Citation

These regulations are the *Electricity* (*Licensing*) *Amendment Regulations* (*No.* 2) 2017.

# 2. Commencement

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette* (*gazettal day*);
- (b) the rest of the regulations on the day after the period of 6 months beginning on gazettal day.

# **3.** Regulations amended

These regulations amend the *Electricity* (*Licensing*) *Regulations* 1991.

# 4. **Regulation 3 amended**

- (1) In regulation 3(1) delete the definitions of:
  electrical installation
  network operator
  W A Electrical Requirements
- (2) In regulation 3(1) insert in alphabetical order:

*de-energised*, in relation to a part of an electrical installation, means separated from each supply of electricity to the part in such a way that the part cannot be inadvertently energised;

# electrical installation means -

- (a) an installation; or
- (b) the network of an exempt operator, other than an exempt operator that is a major network operator; or
- (c) the network of a person who is a network operator under the *Electricity (Network Safety) Regulations 2015* regulation 4(1)(h);

*energised*, in relation to a part of an electrical installation, means connected to a supply of electricity to the part, whether or not electricity is flowing through any part of that part;

*major network operator* means a person who is a network operator under the *Electricity (Network Safety) Regulations 2015* regulation 4(1)(a), (b), (c), (d), (e), (f) or (g);

*network* has the meaning given in the *Electricity* (*Network Safety*) *Regulations* 2015 regulation 3(1);

# 5. Regulation 19 amended

In regulation 19(2):

(a) in paragraph (c) before "network operator" insert:

major

(b) in paragraph (e) delete "network operator service apparatus" and insert:

service apparatus of a major network operator

Delete regulation 49(1)(b) and insert:

At the end of Part 5 insert:

# Division 2 — Regulation of electrical work on energised electrical installations

## 54A. Interpretation

(1) In this Division —

*competent person* has the meaning given in the *Occupational Safety and Health Regulations 1996* regulation 1.3;

*risk assessment*, in relation to electrical work to be carried out on or near an energised part of an electrical installation, means the process of —

- (a) identifying the electrical hazards to which a person carrying out the work is likely to be exposed; and
- (b) assessing the risk of injury or harm, resulting from those hazards, to the person who will carry out the work.

- (2) For the purposes of this Division, a person carries out electrical work near an energised part of an electrical installation if, in carrying out the work, the person may make contact, directly or indirectly (including with a thing used or controlled by the person), with an uninsulated energised part of the electrical installation.
- (3) For the purposes of this Division
  - (a) a part of an electrical installation is taken to be energised unless it is de-energised; and
  - (b) the neutral for a part of an electrical installation is taken to be de-energised if the part is de-energised.

# 54B. Application of regulation 55 in relation to certain network operators

- (1) Regulation 55 does not apply to electrical work carried out on or near the service apparatus of a major network operator if the work is carried out by or on behalf of the network operator.
- (2) Regulation 55 applies in relation to the networks of the following network operators as if regulation 55(2)(b)(i) were deleted
  - (a) a person who is a network operator under the *Electricity (Network Safety) Regulations 2015* regulation 4(1)(h);
  - (b) an exempt operator who is exempt under the *Electricity Industry Exemption Order 2005* clause 13 or 17.

# 55. Electrical work on or near energised electrical installations

- (1) A person who carries out electrical work, or causes electrical work to be carried out, on or near an energised part of an electrical installation commits an offence unless the person carries out the work, or causes the work to be carried out, under subregulation (2).
- (2) A person may carry out electrical work, or cause electrical work to be carried out, on or near an energised part of an electrical installation if
  - (a) a risk assessment has been undertaken by a competent person who is familiar with the type of work to be carried out; and
  - (b) the competent person is satisfied that
    - there is no reasonable alternative to carrying out the work while the part of the electrical installation is energised; and

- (ii) the risks identified by the risk assessment are or can be reduced to as low as reasonably practicable; and
- (iii) the work can be carried out safely; and
- (c) if the Occupational Safety and Health Regulations 1996 regulation 3.143 does not apply to the work, a safe work method statement for the work has been prepared in accordance with regulation 3.143(4) of those regulations, as if the work were high-risk construction work and the place where the work is to be carried out were a construction site; and
- (d) suitable safety and personal protective equipment is used by the person carrying out the work.
- (3) For the purposes of subregulation (2)(b)(i), there is no reasonable alternative to carrying out the work while the part of the electrical installation is energised if one of the following applies
  - (a) it is necessary that the part of the installation be energised for the work to be carried out effectively;
  - (b) it is necessary that the part of the installation be energised because carrying out the work by alternative means would put the health or safety of one or more persons in imminent and significant danger;
  - (c) it is necessary that the part of the installation be energised in order to test, measure the performance of, or detect or locate faults or defects in, the installation or the part of the installation.
- (4) An electrical contractor or the holder of an in-house electrical installing work licence who carries out electrical work, or causes electrical work to be carried out, under subregulation (2) commits an offence unless they ensure, as far as is practicable, that —
  - (a) if the Occupational Safety and Health Regulations 1996 regulation 3.143 does not apply to the work —
    - (i) the work is carried out in accordance with the safe work method statement referred to in subregulation (2)(c); and
    - (ii) if the work is not carried out in accordance with the statement, the work ceases (when safe to do so) and does not

resume until the safe work method statement is complied with;

and

(b) the safety and personal protective equipment referred to in subregulation (2)(d) is used properly by the person carrying out the work.

# Occupational Safety and Health Amendment Regulations 2017

Made by the Governor in Executive Council.

### 1. Citation

These regulations are the Occupational Safety and Health Amendment Regulations 2017.

# 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette* (*gazettal day*);
- (b) the rest of the regulations on the day after the period of 6 months beginning on gazettal day.

## **3.** Regulations amended

These regulations amend the Occupational Safety and Health Regulations 1996.

# 4. **Regulation 1.3 amended**

In regulation 1.3 insert in alphabetical order:

*electrical installation* has the meaning given in the *Electricity (Licensing) Regulations 1991* regulation 3(1);

## 5. Regulation 3.58 replaced

Delete regulation 3.58 and insert:

### 3.58. Interpretation

(1) In this Division, unless the contrary intention appears —

*de-energised*, in relation to a part of an electrical installation, has the meaning given in the *Electricity* (*Licensing*) *Regulations 1991* regulation 3(1);

*electrical work* has the meaning given in the *Electricity* (*Licensing*) *Regulations* 1991 regulation 3(1);

*energised*, in relation to a part of an electrical installation, has the meaning given in the *Electricity* (*Licensing*) *Regulations* 1991 regulation 3(1);

*network operator* has the meaning given in the *Electricity Act 1945* section 5(1).

- (2) For the purposes of this Division, a reference in AS/NZS 3012 to an electricity distributor is to be treated as a reference to a person who is a network operator under the *Electricity (Network Safety) Regulations 2015* regulation 4(1)(a), (b), (c), (d), (e), (f) or (g).
- (3) For the purposes of this Division
  - (a) a part of an electrical installation is taken to be energised unless it is de-energised; and
  - (b) the neutral for a part of an electrical installation is taken to be de-energised if the part is de-energised.

### 6. **Regulations 3.59A and 3.59B inserted**

After regulation 3.59 insert:

### 3.59A. Electrical work

- (1) A person who, at a workplace, is an employer, the main contractor, a self-employed person, a person having control of the workplace or a person having control of access to the workplace must ensure that, before electrical work is carried out on a part of an electrical installation at the workplace, the part —
  - (a) is tested by a competent person to ascertain whether or not it is energised; and

(b) if it is found to be energised, is de-energised by a competent person.

Penalty for this subregulation: the regulation 1.16 penalty.

 (2) Subregulation (1)(b) does not apply to electrical work carried out under the *Electricity (Licensing) Regulations 1991* regulation 55(2).

### 3.59B. Work in roof spaces

(1) In this regulation —

*building* means a Class 1, Class 2 or Class 10a building as classified under the *Building Regulations 2012*;

*roof space*, of a building —

- (a) means the space in the building that is
  - (i) immediately under the roof; or
  - (ii) if there is a ceiling under the roof, or a part of the roof, the space between the roof, or that part of the roof, and the ceiling;

but

(b) does not include a habitable room in the roof space;

*service apparatus* has the meaning given in the *Electricity Act 1945* section 5(1).

(2) A person who, at a workplace, is an employer, the main contractor, a self-employed person, a person having control of the workplace or a person having control of access to the workplace must ensure that, before work is done in a roof space of a building at the workplace, the building's electrical installation is de-energised by a competent person.

Penalty for this subregulation: the regulation 1.16 penalty.

(3) An employee must not do work in a roof space of a building at a workplace unless the building's electrical installation is de-energised by a competent person.

Penalty for this subregulation: the regulation 1.15 penalty.

(4) If the roof space of a building to which subregulation (2) or (3) applies is divided into separate parts, such that a person cannot move from 1 part of the roof space to another, and each part relates to a separate dwelling, the requirement to de-energise the building's electrical installation only applies to the dwelling that relates to the part of the roof space in which the work is to be done.

- (5) Subregulations (2) and (3) do not apply to work done by a competent person to test, service or commission an appliance or other equipment in or accessible by means of the roof space (for example, a gas appliance, air conditioner or antenna), to the extent necessary to energise the appliance or equipment, if —
  - (a) it is necessary to energise the appliance or equipment for the purpose of testing, servicing or commissioning the appliance or equipment; and
  - (b) a risk assessment has been undertaken in accordance with regulation 3.1 by a competent person; and
  - (c) the competent person referred to in paragraph (b) is satisfied that
    - (i) the risks identified by the risk assessment are or can be reduced to as low as reasonably practicable; and
    - (ii) the work can be carried out safely;
    - and
  - (d) if regulation 3.143 does not apply to the work, a safe work method statement for the work has been prepared in accordance with regulation 3.143(4), as if the work were high risk construction work and the place where the work is to be carried out were a construction site.
- (6) Subregulations (2) and (3) do not require the de-energisation of
  - (a) service apparatus that is part of a building's electrical installation; or
  - (b) a supply cable that is part of a building's electrical installation if
    - (i) the cable is from a solar power system, wind turbine or battery; and
    - (ii) it is not practicable to de-energise the cable;
    - or
  - (c) any other part of a building's electrical installation if it is not practicable to de-energise that part.
- (7) Subregulations (2) and (3) do not apply to electrical work carried out under the *Electricity (Licensing) Regulations 1991* regulation 55(2).

### 7. Regulation 3.65 amended

In regulation 3.65 delete "supply authority's" and insert:

network operator's

### 8. Regulation 3.137 amended

In regulation 3.137 insert in alphabetical order:

*energised*, in relation to an electrical installation or line, means connected to a supply of electricity to the installation or line, whether or not electricity is flowing through any part of the installation or line;

Town of Cottesloe

### LOCAL GOVERNMENT PROPERTY AMENDMENT LOCAL LAW 2017

Under the powers conferred by the *Local Government Act 1995* and by all other powers, the Council of the Town of Cottesloe resolved on 14 November 2017 to make the following local law.

### 1. Citation

This local law may be cited as the Town of Cottesloe Local Government Property Amendment Local Law 2017.

#### 2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

#### 3. Principal Local Law

In this local law, the Town of Cottesloe Local Government Property Local Law published in the *Government Gazette* on 15 January 2001 is referred to as the Principal Local Law.

### 4. Principal Local Law amended

The Principal Local Law is amended as set out in clause 5 of this local law.

### 5. Clause 2.8(1)(a) amended

(1) In clause 2.8(1)(a) insert after the word "premises" the words "or within a 5 metre radius of any entrance, exit or aperture of premises".

(2) In clause 2.8(1)(g) delete the word "and".

(3) In clause 2.8(1)(h) replace the full stop at the end of the subclause with a semicolon.

(4) In clause 2.8(1) insert the following additional subclauses after subclause (h)-

- "(i) releasing an unsecured balloon inflated with a gas that causes it to rise in the air; and
- (j) smoking in contravention of a sign which prohibits the act of smoking.".
