Part 1 — Preliminary

1. Citation

These regulations are the *Local Government Regulations Amendment (Cat and Dog) Regulations 2018.*

2. Commencement

- (a) Part 1 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

Part 2 — Cat Regulations 2012 amended

3. **Regulations amended**

This Part amends the Cat Regulations 2012.

4. **Regulation 4 amended**

In regulation 4(b) delete "(Inc) of Western Australia." and insert:

Western Australia (Incorporated).

5. Regulation 6 amended

In regulation 6:

(a) in paragraph (d) delete "Registry";" and insert:

Registry".

(b) delete paragraph (e).

6. **Regulation 9 replaced**

Delete regulation 9 and insert:

9. Cats exempt from registration (s. 5(2)(c) and 9(2)(b))

(1) In this regulation —

- (a) Saving Animals from Euthanasia Incorporated (ABN 59 337 498 934);
- (b) S.A.F.E. Hedland Inc (ABN 23 865 056 223);
- (c) Saving Animals from Euthanasia Busselton Inc (ABN 21 692 235 008).
- (2) For the purposes of sections 5(2)(c) and 9(2)(b) of the Act, a cat that is in the custody of any of the following is exempt from registration
 - (a) Cat Welfare Society Inc., trading as "Cat Haven";
 - (b) Royal Society for the Prevention of Cruelty to Animals Western Australia (Incorporated);
 - (c) the Department of State of the Commonwealth that is administered by the Commonwealth Minister administering the *Biosecurity Act 2015* (Commonwealth);
 - (d) a cat management facility;
 - (e) a veterinary clinic or veterinary hospital as those terms are defined in the *Veterinary Surgeons Act 1960* section 2.
- (3) For the purposes of sections 5(2)(c) and 9(2)(b) of the Act, a cat that is in foster care is exempt from registration if
 - (a) the cat has been placed into that foster care by either of the following
 - (i) Cat Welfare Society Inc., trading as "Cat Haven";

- (ii) Royal Society for the Prevention of Cruelty to Animals Western Australia (Incorporated);
- or
- (b) the cat has been placed into that foster care by a SAFE entity, provided that the cat has not been in foster care for more than a total of 12 weeks.

RETAIL TRADING HOURS (SHIRE OF COLLIE) PUBLIC HOLIDAY VARIATION ORDER 2018 Made by the Minister for Commerce and Industrial Relations under section 12E of the Act.

1. Citation

This order is the Retail Trading Hours (Shire of Collie) Public Holiday Variation Order 2018.

2. Commencement

This order comes into operation as follows-

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*;

3. Variation of retail trading hours

SHARK BAY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993

DETERMINATION OF AREAS CLOSED TO FISHING FOR PRAWNS IN THE

SHARK BAY PRAWN MANAGED FISHERY

Determination No. 1 of 2018

I, Heather Brayford, Chief Executive Officer of the Department of Fisheries, Western Australia, in accordance with clause 10 of the *Shark Bay Prawn Managed Fishery Management Plan 1993*, consider it in the better interest of the Fishery to do so, do hereby—

- 1. Cancel Determination of Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery: Determination No. 2 of 2017 dated 7 September 2017.
- 2. Prohibit fishing for prawns in those parts of the Shark Bay Prawn Managed Fishery (the Fishery), between the times and dates provided for in items (a) to (j) below—
 - (a) fishing for prawns is prohibited in all parts of the Fishery from the date of the gazettal of the Notice advising that I have made *Determination No. 1 of 2018*, until 1700 hours on 7 April 2018, except between 0800 and 1600 hours each day from 24 March 2018 to 7 April 2018 in that part of the Fishery bounded by a line commencing at the intersection of 24° 50' south latitude and 113° 21.50' east longitude; thence extending due south along the meridian to the intersection of 24° 52.75' south latitude and

113° 21.50′ east longitude; thence extending due east along the parallel to the intersection of 24° 52.75′ south latitude and 113° 23.50′ east longitude; thence extending due north along the meridian to the intersection of 24° 50′ south latitude and 113° 23.50′ east longitude; thence extending due west along the parallel to the commencement point—commonly known as the gear trial area.

- (b) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 0800 hours on 16 November 2018—
 - (i) in all nursery areas described in Item 2 of the Schedule of the Shark Bay Prawn Managed Fishery Management Plan 1993;
 - (ii) in that part of the Fishery bounded by a line commencing at the intersection of 25° 36' south latitude and 113° 01.63' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 36' south latitude and 113° 03.75' east longitude; thence extending due south along the meridian to the intersection of 25° 38' south latitude and 113° 03.75' east longitude; thence extending due west along the parallel to the intersection of 25° 38' south latitude and 113° 03.75' east longitude; thence extending due west along the parallel to the intersection of 25° 38' south latitude and 113° 02.29' east longitude (on Dirk Hartog Island); thence generally northerly along the high water mark to the commencement point—commonly known as the "Withnell Point closure"; and
 - (iii) in that part of the Fishery south of a line commencing at the intersection of 25° 40.59' south latitude and 113° 02.87' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 40.59' south latitude and 113° 04.80' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 41' south latitude and 113° 05.63' east longitude; thence extending due east along the parallel to the intersection of 25° 41' south latitude and 113° 08' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 42.40' south latitude and 113° 09.40' east longitude; thence extending due south along the meridian to the intersection of 25° 46.31' south latitude and 113° 09.40' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 48.65' south latitude and 113° 12.17' east longitude; thence extending due east along the parallel to the intersection of 25° 48.65' south latitude and 113° 20.20' east longitude; thence extending due north along the meridian to the intersection of 25° 40' south latitude and 113° 20.20' east longitude; thence extending due west along the parallel to the intersection of 25° 40 south latitude and 113° 19 east longitude; thence extending due north along the meridian to the intersection of 25° 38' south latitude and 113° 19' east longitude; thence extending northeasterly along the geodesic to the intersection of 25° 32' south latitude and 113° 25' east longitude; thence extending due east along the parallel to the intersection of 25° 32' south latitude and 113° 29.74' east longitude (on Peron Peninsula near Bottle Beach); and in that part of the Fishery east of a line commencing at the intersection of 26° 07.30' south latitude and 113° 10.90' east longitude (on Dirk Hartog Island at Surf Point); thence extending south-westerly along the geodesic to the intersection of 26° 08.62' south latitude and 113° 09.60' east longitude (on the mainland near Steep Point)-commonly known as the "Extended Snapper/Trawl closure".
- (c) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 1700 hours on 5 May 2018 and from 0800 hours on 26 June 2018 to 1700 hours on 1 November 2018 in that part of the Fishery bounded by a line commencing at the intersection of 24° 52.75′ south latitude and 113° 37.60′ east longitude (on Babbage Island); thence extending due west along the parallel to the intersection of 24° 52.75′ south latitude and 113° 21′ east longitude; thence extending due south along the meridian to the intersection of 24° 58.10′ south latitude and 113° 21′ east longitude; thence extending due south along the meridian to the intersection of 24° 58.10′ south latitude and 113° 21′ east longitude; thence extending due east along the parallel to the intersection of 25° 03′ south latitude and 113° 22.46′ east longitude; thence extending due east along the parallel to the intersection of 25° 03′ south latitude and 113° 40.70′ east longitude (on the mainland); thence generally northerly along the high water mark to the commencement point—commonly known as the "North Carnarvon Peron Line closure".
- (d) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 1700 hours on 13 June 2018 in that part of the Fishery bounded by a line commencing at the intersection of 25° 03' south latitude and 113° 40.70' east longitude (on the mainland); thence extending due west along the parallel to the intersection of 25° 03' south latitude and 113° 22.46' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 03.261' south latitude and 113° 30.60' east longitude (at Cape Peron North); thence extending due north along the meridian to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 50.83' east longitude (on the mainland); thence generally northerly along the high water mark to commencement point—commonly known as the "Central Carnarvon Peron Line closure".
- (e) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 1700 hours on 3 July 2018 and from 0800 hours on 24 August 2018 to 0800 hours on 16 November 2018 in that part of the Fishery bounded by a line commencing at the intersection of 25° 26' south latitude and 113° 55.55' east longitude (on the mainland); thence

extending due west along the parallel to the intersection of $25^{\circ} 26'$ south latitude and $113^{\circ} 40'$ east longitude; thence extending north-westerly along the geodesic to the intersection of $25^{\circ} 20.40'$ south latitude and $113^{\circ} 30.60'$ east longitude; thence extending due north along the meridian to the intersection of $25^{\circ} 15.20'$ south latitude and $113^{\circ} 30.60'$ east longitude; thence extending due east along the parallel to the intersection of $25^{\circ} 15.20'$ south latitude and $113^{\circ} 50.83'$ east longitude (on the mainland); thence generally southerly along the high water mark to the commencement point—commonly known as the "South Carnarvon Peron Line closure".

- (f) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 1700 hours on 9 August 2018 in that part of the Fishery south of a line commencing at the intersection of 25° 40' south latitude and 113° 02.90' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 40' south latitude and 113° 25.31' east longitude; and in that part of the Fishery east of a line commencing at the intersection of 26° 07.30' south latitude and 113° 10.90' east longitude (on Dirk Hartog Island at Surf Point); thence extending south-westerly along the geodesic to the intersection of 26° 08.62' south latitude and 113° 09.60' east longitude (on the mainland at Steep Point) commonly known as the "Southern Denham Sound closure"
- (g) fishing for prawns is prohibited from 1700 hours on 7 April 2018 to 1700 hours on 10 August 2018 and from 0800 hours on 20 August 2018 to 1700 hours on 6 September 2018 and from 0800 hours on 16 September 2018 to 0800 hours on 16 November 2018 in that part of the Fishery south of a line commencing at the intersection of 25° 40.59' south latitude and 113° 02.87' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 40.59' south latitude and 113° 04.80' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 41' south latitude and 113° 05.63' east longitude; thence extending due east along the parallel to the intersection of 25° 41' south latitude and 113° 08' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 46' south latitude and 113° 13' east longitude; thence extending due east along the parallel to the intersection of 25° 46' south latitude and 113° 19' east longitude; thence extending due north along the meridian to the intersection of 25° 38' south latitude and 113° 19' east longitude; thence extending north-easterly along the geodesic to the intersection of 25° 32' south latitude and 113° 25' east longitude; thence extending due east along the parallel to the intersection of 25° 32' south latitude and 113° 29.74' east longitude (on Peron Peninsula near Bottle Beach); and in that part of the Fishery east of a line commencing at the intersection of 26° 07.30' south latitude and 113° 10.90' east longitude (on Dirk Hartog Island at Surf Point); thence extending south-westerly along the geodesic to the intersection of 26° 08.62' south latitude and 113° 09.60' east longitude (on the mainland at Steep Point)-commonly known as the "Snapper/Trawl closure".
- (h) in parts of the Fishery north of 24° 45.30' south latitude where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 1000 hours and 1700 hours each day between 7 April 2018 and 16 November 2018—commonly known as the "area north of Koks Island".
- (i) in parts of the Fishery south of 24° 45.30' south latitude where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 0800 hours and 1700 hours each day between 7 April 2018 and 16 November 2018—commonly known as the "area south of Koks Island".
- (j) fishing for prawns is prohibited in all parts of the Fishery from 0800 hours on 16 November 2018 to 0800 hours on 1 June 2019.

FISH RESOURCES MANAGEMENT ACT 1994 KIMBERLEY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993 AREAS CLOSED TO FISHING FOR PRAWNS IN THE KIMBERLEY PRAWN MANAGED FISHERY FOR 2018

Notice No. 1 of 2018

I, Heather Brayford, Deputy Director General of the Department of Primary Industries and Regional Development, Western Australia, in accordance with clause 17 of the *Kimberley Prawn Managed Fishery Management Plan 1993* (the Plan) and being of the opinion that the prohibition is required in the better interests of the Kimberley Prawn Managed Fishery, do hereby—

1. Cancel Notice of Areas Closed to Fishing for Prawns: Notice No. 1 of 2017, dated 27 March 2017; and

- 2. Prohibit fishing for prawns in those parts of the Kimberley Prawn Managed Fishery (the Fishery), between the times and dates provided for in items (a) to (e) below—
 - (a) Fishing for prawns is prohibited in the waters described in Schedule 1 of the Plan from the date of the gazettal of *Notice No. 1 of 2018*, until 0600 hours WST on 1 April 2018;
 - (b) Fishing for prawns is prohibited in the waters described in Schedule 1 of the Plan during the period commencing at 0800 hours WST on 15 June 2018 and ending at 0600 hours WST on 1 August 2018;
 - (c) Fishing for prawns is prohibited in the waters described in Schedule 1 of the Plan during the period commencing at 1630 hours WST on 30 November 2018 until 0600 hours WST on 1 June 2019;
 - (d) Fishing for prawns is prohibited in the waters described in (i) to (ii) below from the date of gazettal of this Notice until 0800 hours on 15 June 2018—

(i) Collier Bay Prawn Size Management Fish Ground

Waters inshore of a line commencing at the intersection of 16° 15.34' south latitude and 124° 00' east longitude; thence extending due north along the meridian to the intersection of 15° 50' south latitude and 124° 00' east longitude; thence extending due east along the parallel to the intersection of 15° 50' south latitude and 124° 24.50' east longitude; but excluding all waters described in (e)(i) Collier Bay Inshore Closure;

(ii) Napier Broome Bay Prawn Size Management Fish Ground

Waters inshore of a line commencing at the intersection of 13° 56.84' south latitude and 126° 33.88' east longitude (on the mainland near Anjo Hill); thence extending easterly along the geodesic to the intersection of 13° 56.26' south latitude and 126° 41.12' east longitude (on West Governor Island); thence extending easterly along the geodesic to the intersection of 13° 55.75' south latitude and 126° 48.38' east longitude (on the mainland near Curran Point); but excluding all waters described in (e)(iv) Napier Broome Bay Inshore Closure;

(e) Fishing for prawns is prohibited in the waters described in (i) to (iv) below at all times—

(i) Collier Bay Inshore Closure

Waters inshore of a line commencing at the intersection of 15° 52.09' south latitude and 124° 26.20' east longitude; thence extending southerly along the geodesic to the intersection of 16° 04.20' south latitude and 124° 26.30' east longitude; thence extending south-westerly along the geodesic to the intersection of 16° 17' south latitude and 124° 18.10' east longitude; thence extending westerly along the geodesic to the intersection of 16° 17.195' south latitude and 124° 07.861' east longitude;

(ii) Brunswick Bay-York Sound Inshore Closure

Waters inshore of a line commencing at the intersection of 15° 15.40' south latitude and 124° 40.57' east longitude (on the mainland near High Bluff); thence extending north-easterly along the geodesic to the intersection of 15° 09.50' south latitude and 124° 50' east longitude (on the mainland near Cape Wellington); thence extending north-easterly along the geodesic to the intersection of 15° 00.45' south latitude and 124° 54.20' east longitude (on Coronation Island); thence extending north-easterly along the geodesic to the intersection of 14° 57.90' south latitude and 125° 01.20' east longitude (on Ena Island); thence extending north-easterly along the geodesic to the intersection of 14° 45.30' south latitude and 125° 08.10' east longitude; thence extending north-easterly along the geodesic to the intersection of 14° 43.95' south latitude and 125° 09.45' east longitude; thence extending north-easterly along the geodesic to the intersection of 14° 43.95' south latitude and 125° 09.45' east longitude; thence extending north-easterly along the geodesic to the intersection of 14° 43.95' south latitude and 125° 09.45' east longitude; thence extending north-easterly along the geodesic to the intersection of 14° 43.95' south latitude and 125° 09.59' east longitude (on the mainland near Cape Pond);

(iii) Admiralty Gulf Inshore Closure

Waters inshore of a line commencing at the intersection of 14° 19.50' south latitude and 125° 43.50' east longitude; thence extending south-easterly along the geodesic to the intersection of 14° 26.17' south latitude and 125° 48.79' east longitude; thence extending due east along the parallel to the intersection of 14° 26.17' south latitude and 125° 54.54' east longitude; thence extending north-easterly along the geodesic to the intersection of 14° 19.40' south latitude and 125° 57.60' east longitude (on South West Osborn Island); thence extending due east along the parallel to the intersection of 14° 19.40' south latitude and 126° 05.31' east longitude;

(iv) Napier Broome Bay Inshore Closure

Waters inshore of a line commencing at the intersection 14° 02.63' south latitude and 126° 29.57' east longitude; thence extending south-easterly along the geodesic to the intersection of 14° 05.20' south latitude and 126° 31.30' east longitude; thence extending south-easterly along the geodesic to the intersection of 14° 06.35' south latitude and 126° 35.51' east longitude; thence extending north-easterly along the geodesic to the intersection of 13° 58.30' south latitude and 126° 42.20' east longitude; thence extending north-easterly to the intersection of 13° 55.75′ south latitude and 126° 48.38′ east longitude (on the mainland near Curran Point).

MENTAL HEALTH ACT 2014

MENTAL HEALTH (AUTHORISED MENTAL HEALTH PRACTITIONERS) REVOCATION ORDER (NO. 4) 2018

Made by the Chief Psychiatrist under section 539 of the Mental Health Act 2014.

1. Citation

This Order may be cited as the Mental Health (Authorised Mental Health Practitioners) Revocation Order (No. 4) 2018.
