#### 1. Citation

These regulations are the *Liquor Control (Yakanarra Restricted Area) Amendment Regulations 2018.* 

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

APPROVAL OF AMENDMENTS TO THE WA GAS RETAIL MARKET SCHEME

The Economic Regulation Authority, pursuant to Section 11ZOM of the *Energy Coordination Act 1994*, hereby gives notice that the following amendments to the to the Western Australian gas retail market scheme (scheme) have been approved—IN002/17W and IN003/17W—

- IN002/17W—proposes changes to Chapter 9 of the Retail Market Procedures to improve the clarity of the procedure change process for the scheme.
- IN003/17W—proposes changes to the Retail Market Procedures and the Specification Pack to allow for identification of the previous retailer in a customer transfer transaction.

IN002/17W is approved subject to correction of the grammatical and formatting errors in the proposed procedures identified by the ERA in its decision paper. IN003/17W is approved as submitted to the ERA by AEMO on 25 January 2018.
