LOTTERIES COMMISSION ACT 1990

LOTTERIES COMMISSION (AUTHORISED LOTTERIES) AMENDMENT RULES 2019

Made by the Lotteries Commission under section 28(1) of the Act.

1. Citation

These rules are the Lotteries Commission (Authorised Lotteries) Amendment Rules 2019.

2. Commencement

These rules come into operation as follows—

- (a) rules 1, 2 and 3—on the day on which these rules are published in the *Gazette*;
- (b) rule 4(1) and (3)—immediately after the Monday Lotto draw on 25 November 2019:
- (c) rule 4(2) and (4)—immediately after the Wednesday Lotto draw on 27 November 2019;
- (d) rule 5—immediately after the OZ Lotto draw on 26 November 2019;
- (e) rule 6—immediately after the Powerball draw on 21 November 2019;
- (f) rule 7—immediately after the Saturday Lotto draw on 23 November 2019; and
- (g) rule 8—immediately after the Set for Life draw on 29 November 2019.

3. Rules amended

These rules amend the Lotteries Commission (Authorised Lotteries) Rules 2016.

SCHOOL EDUCATION ACT 1999

NON-GOVERNMENT SCHOOL SYSTEM ORDER 2019

Made by the Minister for Education under section 169 of the School Education Act 1999.

1. Citation

This order may be cited as the Non-Government School System Order 2019.

2. Commencement

- (1) This order comes into effect on 1 January 2020.
- (2) The Non-Government School System Order 2009 is revoked with effect from 31 December 2019.

3. Recognition of the Catholic Education System

- (1) The schools listed in the Schedule are declared to be members of a recognised school system to be known as the Catholic Education System.
- (2) The governing body of the Catholic Education System is Catholic Education Western Australia Limited, of 50 Ruislip Street, Leederville WA 6007.
- (3) Catholic Education Western Australia Limited may add member schools to and remove member schools from the Catholic Education System by notice given to the Minister.
