Given under the *Letters Patent relating to the office of Governor of the State of Western Australia* dated 14 February 1986 clause XXI.

1. Citation

This notice is the *Lieutenant-Governor of Western Australia and Administrator Notice 2019*.

2. Office of Lieutenant-Governor

- (1) On 27 November 2019 the Honourable Chief Justice Peter Damien Quinlan assumed the office of Lieutenant-Governor after taking the Oath of Allegiance and the Oath of Office, as required by the *Letters Patent relating to the office of Governor of the State of Western Australia* dated 14 February 1986 clause XVII.
- (2) The text of each commission appointing the Honourable Chief Justice Peter Damien Quinlan as the Lieutenant-Governor and the Administrator is set out in the Schedule to this notice.

This Commission under the *Letters Patent relating to the office of Governor of the State of Western Australia* dated 14 February 1986 clause XV, the *Australia Act 1986* (Commonwealth) section 7(2) and the *Australia Act 1986* (UK) section 7(2) is issued by the Governor.

1. The Honourable Chief Justice Peter Damien Quinlan is appointed to be the Lieutenant-Governor of the State of Western Australia with all of the powers, rights, privileges and advantages belonging or appertaining to that office.
2. When the Lieutenant-Governor is required by the *Letters Patent relating to the office of Governor of the State of Western Australia* dated 14 February 1986, or by future Letters Patent relating to the office of Governor, to administer the government of the State, the Honourable Chief Justice Peter Damien Quinlan —
 - (a) is appointed to be the Administrator; and
 - (b) is authorised and required to exercise and perform all or any of the powers, functions and directions contained in those Letters Patent according to the laws from time to time in force in the State.
3. As soon as the Honourable Chief Justice Peter Damien Quinlan has taken the usual Oath of Allegiance and the usual Oath of Office and has assumed the office of Lieutenant-Governor, any commission appointing the Honourable Wayne Stewart Martin AC to be the Lieutenant-Governor of the State of Western Australia and the Administrator is revoked.
