LOTTERIES COMMISSION ACT 1990

LOTTERIES COMMISSION (INSTANT LOTTERY) AMENDMENT RULES 2019 Made by the Lotteries Commission under section 28(1) of the Act.

1. Citation

These rules are the Lotteries Commission (Instant Lottery) Amendment Rules 2019.

2. Commencement

These rules come into operation as follows—

- (a) rules 1 and 2—on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules—on the day after that day.

3. Rules amended

These rules amend the Lotteries Commission (Instant Lotteries) Rules 1996.

4. Rule 2 amended

(1) In rule 2 in the definition of agent delete the words "and includes the any branch or section of the Commission;" and insert—

and includes any branch or section of the Commission;

- (2) In rule 2 delete the definition of *authorised payout centre*.
- (3) In rule 2 insert in alphabetical order—

instant lottery promotion means a second stage draw competition run by the Commission involving one or multiple instant lotteries;

ticket identification number has the meaning given in rule 4A;

validation period applies to prizes of \$5,000 or more and means the period of time commencing at midnight on the day of presentation of the winning instant lottery ticket at the Lotteries Commission head office and ending at the close of business on the 14th day following that day (or on the business day preceding that 14th day, if the day falls on a public holiday);

(4) In rule 2 in the definition of *name and address* delete "residential or postal address" and insert—

residential address and postcode

5. Rule 3 amended

In subrule 3(2) delete the words "instant lotteries which involve a second stage draw" and insert—

instant lottery promotions

6. Rule 4 amended

- (1) In rule 4(3)—
 - (a) after the words "ticket is not part of" delete "an instant lottery, or"
 - (b) after the words "for the lottery," in the second line insert—and
 - (c) after the word "lottery" in the last line insert or an instant lottery promotion.

7. Rule 4A inserted

After rule 4 insert-

4A. Ticket identification number

The Commission may include on any part of a ticket a unique identification distinguishing number (*ticket identification number*) which may be used for the purposes of rule 9AA(3).

8. Rule 5A inserted

After rule 5 insert—

5A. Issue of Tickets

The Commission may nominate a date on the Lotterywest website for when the Commission will cease to issue tickets in a particular lot of tickets to an agent for sale irrespective of whether the Commission has unsold books.

9. Rule 6 amended

(1) In rule 6(a) after "void if removed" insert—

"or agent use only"

- (2) Delete rule 6(c) and insert—
 - (c) has the words "void", "not for sale" or "specimen" marked under the "void if removed" or "agent use only" panel, or elsewhere on the ticket;

 - (2) An instant prize is to be paid to the holder of the winning ticket when the ticket is presented to either the Commission or the agent depending on the amount of the instant prize within the payout period for that ticket and after any applicable validation period.
- (3) In rule 9(3)—

 - (b) delete the words "subrule (1)".
 - (c) after the words "ticket presented in accordance with" insert—this rule
 - (d) In subrule 9(3)(b) delete "verified through a computer linked terminal" and insert—

identified through a computer linked terminal as having been paid,

12. Rule 9A inserted

After rule 9 insert—

9A. Validation Period

- (1) If a player wins a prize and there is no validation period for the relevant instant lottery game, the Commission must pay the prize to the player as soon as is practicable after presentation of the ticket.
- (2) The requirement to pay a prize is dependent on a claim being made by the player and the player confirming their identity and bank account details for the Commission.
- (3) If there is a validation period to claim the prize, the Commission must pay the prize to the player following the conclusion of the validation period provided the conditions under subrule (2) have been met, save that the Commission may exercise it's absolute discretion to pay a prize prior to the expiry of the validation period.

13. Rule 9AA inserted

In Part 4—Second Stage insert new rule 9AA before rule 10—

9AA. Entries

- (1) For the purposes of this Part, a person may enter a ticket in the second stage of an instant lottery or an instant lottery promotion by—
 - (a) digitally entering the ticket in accordance with subrules (2) and (3); or
 - (b) such other means as directed by the Commission.
- (2) A ticket is digitally entered in the second stage of an instant lottery or an instant lottery promotion if the holder of the ticket successfully

enters the ticket in the second stage of the lottery by means of the Lotterywest website or as directed by the Commission.

(3) The holder of a ticket must, at the time of digitally entering the ticket in the second stage of an instant lottery or an instant lottery promotion, provide the ticket identification number of the ticket.

14. Rule 10 amended

(1) In rule 10(1) delete "The Commission must ensure that the second stage of an instant lottery is supervised" and insert—

The Commission must ensure that the draw or selection of a potential winning ticket in the second stage of an instant lottery or an instant lottery promotion is supervised

- (2) Delete rule 10(1)(a) and (b) and insert—
 - (a) by an officer from the department of the Public Service principally assisting in the administration of the *Gaming and Wagering Commission Act 1987*; or
 - (b) where, in the opinion of the Commission, it is not necessary for an officer referred to in paragraph (a) to supervise that stage of the lottery, by such person and in such a manner as determined by the Commission.

Supervision of draw or selection of tickets

15. Rule 11 replaced

11. Eligibility for second stage prizes

A ticket is not eligible to win a prize in the second stage of an instant lottery or an instant lottery promotion if the ticket—

- (a) does not have the name and address of the person to whom any prize relating to that ticket is to be paid clearly printed in the appropriate space on the back of the ticket; or
- (b) is not signed by that person or a person acting on that person's behalf; or
- (c) the holder of the ticket has not complied with rule 12(1A) where the ticket was digitally entered in the second stage of the lottery

16. Rule 12 amended

After subrule 12(1) insert—

(1A) If the drawn or selected ticket was digitally entered in the second stage of the lottery or an instant lottery promotion, the holder of the ticket must provide the ticket to the Commission for the purposes of subrule (1) in the manner notified by the Commission on the Lotterywest website.

 - 1. acting under regulation 19H of the *Navigable Water Regulations 1958* (the Regulations), hereby declare the vessels listed in Schedule 1 (Schedule 1 vessels) to be emergency vessels, with the specifications in Schedule 2; and
 - 2. acting under section 115A of the Western Australian Marine Act 1982 (the Act), hereby exempt (the exemption) the Schedule 1 vessels from notices made under—

Schedule 2—Declaration specifications

- 1. A Schedule 1 vessel is only operating as an emergency vessel when it is being used in relation to sea search and rescue or other situations where serious injury and/or loss of life can either be reasonably expected or has been reported to the vessel master or crew ('identified emergency').
- 2. Before a Schedule 1 vessel is so used, or as soon as practicable if extraordinary circumstances inhibit compliance with paragraphs (a) to (c) below, the master of a Schedule 1 vessel, must—
 - (a) notify a police officer, or a police marine communications officer, of the particulars of the identified emergency;
 - (b) notify that person which vessel it is they are master of; and
 - (c) have received police authorisation that is required in the circumstances.
- 3. Regulation 19A (speed limit in Swan and Canning Rivers) and regulation 48 (limitation of speed) of the Regulations do not apply to a Schedule 1 vessel when it is being used as an emergency vessel.
- 4. A lamp displaying intermittent blue flashes—
 - (a) may be used on a Schedule 1 vessel at any time it is
 - i. operating as an emergency vessel; or
 - ii. supporting an aquatic event approved under regulation 51C of the Regulations, under the direction of a DoT Marine Inspector appointed pursuant to section 117 of the Act;
 - (b) must be used on a Schedule 1 vessel when it is operating as an emergency vessel and exceeding the speed limit, operating in closed waters, or both of those.
- 5. The operator of a Schedule 1 vessel when it is operating as an emergency vessel must hold, as a minimum, a Recreational Skippers Ticket.
- 6. The master of a Schedule 1 vessel when it is operating as an emergency vessel must—
 - (a) assess if it is appropriate to exceed the speed limit; and
 - (b) comply with the Prevention of Collisions at Sea Regulations 1983 including
 - i. Rule 5 (Look-out);
 - ii. Rule 6 (Safe Speed); and
 - iii. Rule 7 (Risk of Collision).
- 7. The master and crew of a Schedule 1 vessel must comply with a direction issued by a Police officer or a DoT Marine Inspector (designated under section 117 of the Act), including a direction to provide a situation report in relation to the identified emergency.

Schedule 3—Exemption Conditions

- 1. The Schedule 1 vessel is being used in relation to an identified emergency.
- 2. A lamp displaying intermittent blue flashes is used on the Schedule 1 vessel when it is exceeding the speed limit, operating in closed waters, or both of those.
- 3. The operator of the Schedule 1 vessel holds, as a minimum, a Recreational Skippers Ticket.
- 4. Before the Schedule 1 vessel is used as an emergency vessel, or as soon as practicable if extraordinary circumstances inhibit compliance with paragraphs (a) to (c) below, the master—
 - (a) notifies a Police officer, or a police marine communications officer, of the particulars of the identified emergency;
 - (b) notifies that person which vessel it is they are master of; and
 - (c) receives from that person any authorisation that is required in the circumstances.

- 5. The master of a Schedule 1 vessel complies with the Prevention of Collisions at Sea Regulations 1983 including—
 - (a) rule 5 (Look-out);
 - (b) rule 6 (Safe Speed);
 - (c) rule 7 (Risk of Collision).
- 6. At all times that the Schedule 1 vessel is exceeding any speed limit, the master is assessing the extent to which, if any, it is appropriate to do so.
- 7. At all times that the Schedule 1 vessel is operating in closed waters, the master is assessing whether it is appropriate to do so.
- 8. The master and crew of a Schedule 1 vessel complies with directions issued by Police officers and DoT Marine Inspectors (designated under section 117 of the Act), including directions to provide information and situation reports in relation to the identified emergency.

Note: A master of a Schedule 1 vessel when it is operating as an emergency vessel, is not required to hold a commercial Certificate of Competency under regulation 28 of the *W.A. Marine (Certificates of Competency and Safety Manning) Regulations 1983.* However, the Department of Fire and Emergency Services may require the master to hold a minimum qualification higher than the Recreational Skippers Ticket required by this instrument.
