SOIL AND LAND CONSERVATION ACT 1945

SOIL AND LAND CONSERVATION (YALLINGUP LAND CONSERVATION DISTRICT) AMENDMENT ORDER 2019

Made by the Governor in Executive Council under section 23 (2d) of the *Soil and Land Conservation Act 1945* on the recommendation of the Minister for Agriculture and Food.

Citation

1. This order may be cited as the Soil and Land Conservation (Yallingup Land Conservation District) Amendment Order 2019.

Commencement

2. This order commences from the date of publication in the Gazette.

Principal Order

3. In this order the Soil and Land Conservation (Yallingup Land Conservation District) Order 1993* is referred to as the principal order.

Principal order amended

4. The Principal order is amended by deleting clause 5 and substituting the following-

"5. It is hereby determined, on the recommendation of the Minister, after consultation with the Shire of Busselton, that the committee shall comprise 13 members of whom—

- (a) one shall be the Commissioner of Soil and Land Conservation (Commissioner) or his or her nominee;
- (b) one shall be appointed by the Commissioner on the nomination of the Shire of Busselton; and
- (c) 11 shall be appointed by the Commissioner and shall be persons actively engaged in, or affected by or associated with, land use in the district."

GOVERNMENT RAILWAYS (PARKING STATIONS) BY-LAW 1997

Alternate Method of Payment

Pursuant to the provisions of By-law 14(4) of the *Government Railways (Parking Stations) By-law* 1997, the Public Transport Authority of Western Australia (**Transperth**) gives notice that it has approved an alternative method of payment for parking vehicles in its car parks as described below.

For the purposes of this notice, 'vehicle' includes a motor vehicle, a motorcycle and a motorised scooter.

With effect on and from 11 November 2019, Transperth has approved a paperless method for the payment of parking charges for vehicles by cash or by SmartRider card. Cash payments are not available at some Transperth carparks.

If paying by cash or using an unregistered Smartrider after parking a vehicle approach the Pay By Plate machine. Press the Pay By Plate button to activate the machine then enter the vehicle's licence plate number then press the green tick symbol.

Select a payment method by pressing either 1 (coins) or 2 (SmartRider). For SmartRider payment, place the SmartRider card on the target icon until a confirmation beeping sound is emitted and the screen reads 'Payment O.K \$2'.

For cash payment (where available), insert \$2 in coin(s) into the machine.

Collect the receipt for a record of the transaction.

A person with a registered Smartrider card may use the SmartParker parking machine or the Pay by Plate machine to pay the applicable parking charge, by pressing the green button on either machine and placing their SmartRider card against the SmartRider target on the machine.

A person who has insufficient credit on their SmartRider card must either pay in cash or add credit to their SmartRider card to pay the parking charge.

No parking ticket will be dispensed from the Pay by Plate machine. Transperth will use licence plate recognition software at each parking station to check that parked vehicles have paid the applicable parking charge.

Persons using their SmartRider card to pay for parking must "tag on" with the same SmartRider card to a Transperth public passenger transport service from the station they have parked at on the same day they have parked. Persons who fail to "tag on" after paying for parking on two consecutive occasions will have their card blocked and will be prevented from using their SmartRider card to pay for parking the next time they use a PTA parking station. The ability to "tag on" and "tag off" Transperth public passenger transport services will not be affected during this time.
