1. Citation

This order is the *Health Services (Fees and Charges) Amendment Order 2020.*

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Order amended

This order amends the *Health Services (Fees and Charges) Order 2016.*

4. Part 2 heading amended

In the heading to Part 2 delete "Scale of fees" and insert:

5. Clause 5 amended

In clause 5(2):

(a) in paragraph (c) delete "applies." and insert:

applies; or

- (b) after paragraph (c) insert:

6. Clause 10A inserted

At the end of Part 2 insert:

10A. Provision of medicines

- (1) The charge for the provision of a medicine in a hospital to a patient of any of the following classes is to be of an amount determined by the Department CEO according to the cost of providing the medicine —
 - (a) ineligible in-patient;
 - (b) ineligible out-patient;
 - (c) ineligible day patient;
 - (d) ineligible same day patient.
- (2) The Department CEO must ensure that a determination made under subclause (1) is publicly available.

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the Town of Bassendean Local Planning Scheme amendment on 8 January 2020 for the purpose of—

- 1. Amending Table 1—Zoning Table to
 - a. Change the permissibility of the Service Station land use from an 'A' use to an 'X' use in the Town Centre and Local Shopping zones;
 - b. Change the permissibility of the Convenience Store land use from a 'P' use to a 'D' use in the Town Centre and Local Shopping zones.
- 2. Amend Section 2. Land Use Definitions in Schedule 1—Dictionary of Defined Words and Expressions to delete the existing definition of Convenience Store and replace with the following definition of Convenience Store—

'convenience store' means premises-

- (a) Used for the retail sale of convenience goods commonly sold in supermarkets, delicatessens or newsagents; and
- (b) Operating hours which include, but may extend beyond, normal trading hours; and
- (c) The floor area does not exceed $300m^2$ net lettable area.
- 3. Amendment section 2. Land Use Definitions in Schedule 1—Dictionary of Defined Words and Expressions to delete the existing definition of Service Station and replace it with the following definition of Service Station—

'service station' means premises for—

- (a) The retail sale of petroleum products, motor vehicle accessories and goods of an incidental/convenience retail nature; and/or
- (b) The carrying out of greasing, tyre repairs and minor mechanical repairs to motor vehicles.

But does not include the premises used for a transport depot, panel beating, spray painting, major repairs or wrecking.
