# Health Services (Fees and Charges) Amendment Order (No. 3) 2020

#### SL 2020/58

Made by the Minister under section 56 of the Act.

#### 1. Citation

This order is the *Health Services* (Fees and Charges) *Amendment Order* (No. 3) 2020.

#### 2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

#### 3. Order amended

This order amends the *Health Services* (Fees and Charges) Order 2016.

#### 4. Clause 5 amended

In clause 5(2)(b) delete "to which a fee or charge set out in Schedule 1 Division 5 applies; or" and insert:

to which a charge under clause 9 applies; or

#### 5. Clause 6 amended

In clause 6(2)(b) delete "to which a fee or charge set out in Schedule 1 Division 5 applies; or" and insert:

to which a charge under clause 9 applies; or

#### 6. Clause 9 amended

(1) In clause 9(1) insert in alphabetical order:

adult chargeable patient means a chargeable patient who has reached 18 years of age;

Town Planning Scheme No. 2—Amendment No. 176

It is hereby notified for public information, in accordance with section 87 of the  $Planning\ and\ Development\ Act\ 2005\$ that the Minister for Planning approved the City of Rockingham Town Planning Scheme amendment on 7 May 2020 for the purpose of—

- 1. Amend Table No. 1—Zoning Table to change the permissibility of "Child Care Premises" in the Light Industry zone from a "D" (discretionary use) to a "X" (not-permitted use).
- 2. Replace the existing "R5/40" coding for Residential zoned land bound by Victoria Street, Rockingham Beach Road, Lewington Street and Governor Road, Rockingham with the "R40" coding on Town Planning Scheme Map No. 2.
- 3. Amend clause 4.9 to-
  - (a) Replace all references to "Local Development Plan" with "Structure Plan";
  - (b) Replace all reference to "Chief Executive Officer" with "Western Australian Planning Commission";
  - (c) Replace all reference to "certified" with "approved';
  - (d) Replace clause 4.9.3.2 with the following—
    - "Prior to the consideration of any subdivision or development on Lot 17 and Lot 4 Port Kennedy Drive, Port Kennedy, a Structure Plan shall be submitted for the approval of the Western Australian Planning Commission which addresses, inter alia, the protection of a representative sample of Becher Suite Wetlands, however, not exceeding 10% of the subdivisional area."
- 4. Amend clause 4.17.2 to replace "Residential, Development, Special Rural or Special Residential Zone" with "Residential Zone, Development Zone, Special Residential Zone, Special Rural Zone, Rural Zone, Port Kennedy Business Enterprise Zone, Light Industry Zone, General Industry Zone, Special Commercial Zone and Service Commercial Zone".
- 5. Amend clause 4.17.3—
  - (a) To replace "Residential Zone, Development Zone, Special Rural Zone, or Special Residential Zone" with "Residential Zone, Special Residential Zone, Development Zone, Rural Zone or Special Rural Zone";
  - (b) Delete sub-clause 4.17.3 (c); and
  - (c) Renumber clause 4.17.3 accordingly.
- 6. Amend sub-clause 4.15.1.4(c) as follows—
  - (c) In the Primary Centre Waterfront Village Zone for a purpose which is not specified in Table No. 4, the local government is to determine the minimum number of car parking bays required for the development having regard to—
    - (i) the nature of the proposed development;
    - (ii) the number of employees likely to be employed on the site;
    - (iii) the anticipated demand for parking; and
    - (iv) the orderly and proper planning of the locality.
- 7. Remove "Camping Area" and any associated land use permissibility from the Zoning Table, and remove the "Camping Area" definition from the list of Land Use Interpretations in Schedule 1 of the Scheme Text.


