Made by the Governor in Executive Council.

## 1. Citation

These regulations are the *Hospitals* (*Licensing and Conduct of Private Hospitals*) Amendment Regulations 2020.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

# 1. Citation

- (b) if the licence holder permits a person to bring an animal onto the premises of the private hospital, the animal —
  - (i) is effectively managed; and
  - does not constitute a nuisance or health risk to the patients in the private hospital;

# Planning and Development (Part 17 Fees) Notice 2020

# SL 2020/116

Made by the Minister under section 285 of the Act.

# 1. Citation

This notice is the *Planning and Development (Part 17 Fees) Notice 2020.* 

# 2. Commencement

- (a) clauses 1 and 2 on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice on the day after that day.

# 3. Terms used

In this notice —
*design* includes a draft of the design;

*design review*, in relation to a development that is the subject of a development application to be determined by the Commission under section 274 of the Act, means a review of the design of the development that —

- (a) was conducted, at the request of the applicant, by the State Design Review Panel before, as the case requires —
  - (i) the application was made or referred to the Commission; or
  - (ii) the Commission was directed to determine the application;

or

(b) is conducted by the State Design Review Panel for the purposes of the Commission's consideration of the application;

*State Design Review Panel* means the committee called the State Design Review Panel established under Schedule 2 clause 1 of the Act.

(2) Other terms used in this notice that are also used in Part 17 of the Act have the same meanings in this notice as they have in that Part.

### 4. Fees

- (1) The applicable fee set out in Schedule 1 is payable to the Commission in respect of the following
  - (a) a development application to be determined by the Commission under section 274 of the Act;
  - (b) an application made under section 279(2) of the Act.
- (2) The additional fees set out in subclause (3) are payable to the Commission in respect of a development application to be determined by the Commission under section 274 of the Act if 1 or more design reviews were, or are, conducted in relation to the development.
- (3) The additional fees are
  - (a) \$10 000; and
  - (b) if the number of design reviews is more than 3 -\$5 000 per design review after the  $3^{rd}$  design review.
- (4) A fee payable under this clause is payable by the applicant.
- (5) Neither subclause (1)(a) nor subclause (2) applies to a development application in respect of which a direction was given under section 272(5) of the Act unless the Minister's consideration of the application for the purposes of section 272(4)(b) of the Act was done at the applicant's request.

#### BIOSECURITY AND AGRICULTURE MANAGEMENT REGULATIONS 2013 QUARANTINE AREA NOTICE REVOCATION

The Quarantine Area Notice—*Bactrocera (Bactrocera) tryoni* (Queensland fruit fly or Qfly) Claremont, Nedlands and Dalkeith, published in the *Government Gazette* WA, the West Australian Newspaper, and on the Department of Primary Industries and Regional Development website on 3 April 2020 is revoked and replaced by the following notice—

#### **BIOSECURITY AND AGRICULTURE MANAGEMENT REGULATIONS 2013**

QUARANTINE AREA NOTICE-Bactrocera (Bactrocera) tryoni (Queensland fruit fly or Qfly)

Claremont, Cottesloe, Crawley, Dalkeith, Mount Claremont, Nedlands, Peppermint Grove, Shenton Park and Swanbourne

1. Under regulation 60 of the *Biosecurity and Agriculture Management Regulations 2013* (Regulations) the area of Claremont, Cottesloe, Crawley, Dalkeith, Mount Claremont, Nedlands, Peppermint Grove, Shenton Park and Swanbourne within the boundaries described below is declared to constitute a quarantine area until 1 February 2021.

The area bordered by and including the river line south of Crawley Steps, along the river line to the river line east of Forrest Street, north of Forrest Street, east of Railway Street, north of Eric Street, east of Curtin Avenue, east of West Coast Highway, south of Alfred Road, east of Montgomery Avenue, south of Mooro Drive, east and south of John Xxiii Avenue, east of Brockway Road, south of Lemnos Street, east of Selby Street, south east of Nash Street, under subway, south of Nicholson Road, south west of Thomas Street, west of Winthrop Avenue, south of Poole Avenue, west and south of Park Avenue, west of Forrest Drive, north west of Crawley Steps to the river line.

**Note:** A map of the quarantine area will be published on the website of the Department of Primary Industries and Regional Development.

2. This quarantine area is declared because the declared pest *Bactrocera* (*Bactrocera*) tryoni (Froggatt, 1897) (Queensland fruit fly or Qfly) is present in the area.

3. Each person who is the owner or occupier of land within the quarantine area must ensure that any ripe or ripening fruit on plants or trees, or any fruit that has fallen to the ground from a plant or tree on that land is removed and consumed or treated every three days. Fruit means any host or suspect host of Queensland fruit fly listed in the table in Schedule 1 below.

4. Fruit is to be treated by cooking (e.g. boiling or microwaving), freezing for a minimum of 24 hours, or solarisation (securing in a sealed black plastic bag which is placed on a hard surface in direct sunlight for a minimum period of seven days).

5. Persons, other than persons employed by or on behalf of the Department of Primary Industries and Regional Development, must not move any non-commercially produced fruit from the quarantine area except in accordance with—

- (a) this notice; or
- (b) an approval under regulation 67 of the Regulations; or
- (c) a general exemption under regulation 71 of the Regulations.

6. Non-commercially produced fruit is moved in accordance with this notice if it is moved after being treated.

7. Each person who is the owner or occupier of land in the quarantine area is taken to have been given a quarantine notice that applies to that land in the terms of this quarantine area notice.

8. Failure to comply with this quarantine area notice could result in a fine, the Director General taking remedial action under regulation 133 of the *Biosecurity and Agriculture Management Regulations 2013*, or both.

Notice to All Owners and Occupiers of Land Within the City of Kalamunda

Compliance Due Before: 1 November 2020

Assessments Commence from: 1 November 2020

**Important:** The works outlined below must be completed by 1 November 2020 and maintained in this state up to and including 31 March 2021.

Pursuant to Section 33 of the *Bush Fires Act 1954*, the City of Kalamunda gives you written notice to act as specified in this notice to land that you own and/or occupy and with respect to any matter which is upon the land that you own and/or occupy situated within the district of the City of Kalamunda.

Failure or neglect to comply with the requisitions of this notice is an offence and can result in a penalty of up to \$5000. The City of Kalamunda gives you notice that its officers, servants, workmen, contractors, vehicles, machinery and appliances (as the officers deem fit) may enter upon the land and carry out the requisitions of this notice that are not complied with by the time specified in the notice, and the amount of any costs and expenses incurred may be recovered from you as the owner and/or occupier of the land

#### ALL LAND WITH A TOTAL AREA OF 4000m<sup>2</sup> OR MORE

### • Fire-Breaks

Install or upgrade a 3-metre-wide by 4-metre-high clearance, bare mineral earth, continuous (no dead ends) trafficable fire-break as close as possible inside the entire perimeter of the land. A reticulated and maintained green lawn may be accepted in lieu of a firebreak.

#### • Dead Flammable Material

Maintain all dead flammable material below 8 tonne per hectare (see definition fuel load).

#### • Slashing

Dead grass, shrubs and plants shall be slashed, mowed, or trimmed down to a height no greater than 50mm across the entire property.

#### • Asset Protection Zone (APZ)

Maintain a fuel reduced zone around all buildings or assets of value which extends 20 metres from the outermost point of the building or asset.

- » Ensure gutters, roofs and walls of buildings are free of flammable matter.

- » Trees over 5 metres in height must be under pruned up to 2 metres.

#### VARIATION TO THE FIRE HAZARD REDUCTION NOTICE

If you consider, for any reason, that it is impractical to meet the requirements as per this notice, you may apply in writing for a variation to the requirements of this notice to the City of Kalamunda by no later than 1 October 2020, to request authorisation to employ other methods of fire prevention to land that you own and/or occupy. An administration fee of \$150 applies for applications received after 1 October 2020.

If permission is not granted to you for a variation of this notice, you must comply with the requirements outlined in the Fire Hazard Reduction Notice.

#### Additional Works

In addition to the requirements of this notice, regardless of land size, you may be required to carry out further fire prevention works on your land to reduce any hazards considered necessary by the duly Authorised Officer of the City of Kalamunda. If required, these requirements will be outlined in a 'work order' sent to the address of the owner and/or occupier.

#### **Emergency Management Plans and City Approved Treatment Plans**

All properties and/or land that are subject to a Bushfire Management Plan, Emergency Management Plan or an approved Bushfire Attack Level assessment (BAL), as a result of subdivision, development application or a City approved treatment plan must comply with the requirements of such plans in their entirety. Compliance with any additional plans does not constitute compliance with this notice.

#### DEFINITIONS

#### Firebreak

A strip of land cleared of all flammable material with the intention of minimising the spread or extension of a bushfire and provide safe access on your property for emergency vehicles and other firefighting operations.

- » No less than 3 metres wide and 4 metres height clearance inside and along all boundaries (including boundaries adjacent to roads, rail and drain reserves and all public open space reserves).
- » Must have a corner turning radius of up to 10 metres.
- » Must be a mineral earth break with a continuous trafficable surface for a 4WD vehicle, clear of any obstructions and must not terminate in a cul-de-sac (dead end).
- » Maintained and living lawns are acceptable in conjunction with or in lieu of mineral earth fire breaks, provided that the same width and height requirements for a fire break are applied.
- » Must not be more than 4 metres wide (further width extensions may be considered upon written application for approval to the City).

#### Fuel Load

Any material such as wood, leaves and grass that is likely to be ignited and capable of burning.

- » Leaf litter on the ground inclusive of leaves, twigs (up to 6mm diameter) and bark. A fuel load depth of 15mm from the top layer to the mineral earth beneath is indicative of approximately 8 tonne per hectare
- $\,$   $\,$  Mulch piles, stored firewood and burn piles contribute to fuel load and must be stored safely or removed from the property.


