City of Gosnells

Standing Orders Amendment Local Law (Number 2) 2020

Under the powers conferred by the *Local Government Act 1995*, and under all other powers enabling it, the Council of the City of Gosnells resolved on 9 February 2021 to make the following local law.

PART 1—PRELIMINARY

1.1 Citation

This local law is the City of Gosnells Standing Orders Amendment Local Law (Number 2) 2020.

1.2 Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

1.3 Principal local law amended

This local law amends the City of Gosnells Standing Orders Local Law 2016.

PART 2—AMENDMENT

2.1 City of Gosnells Standing Orders Local Law 2016 amended.

This local law amends the City of Gosnells Standing Orders Local Law 2016 as published in the Government Gazette on 1 December 2016.

2.2 Clause 4.6 amended

In clause 4.6(1) after the word "matter" delete the words "that appears" and insert the words "included under parts 12 through 16".

EXTENSION OF DECLARATION (No. 2) OF PUBLIC HEALTH STATE OF EMERGENCY

Pursuant to section 170 of the *Public Health Act 2016* (WA) I, Roger Cook, the Minister for Health, hereby extend the public health state of emergency declaration, which came into effect on 23 March 2020 at 13:30 hours.

COVID-19 RESPONSE AND ECONOMIC RECOVERY OMNIBUS ACT 2020

COVID-19 RESPONSE AND ECONOMIC RECOVERY (VESSEL ACCOMMODATION FEE RELIEF) ORDER 2021

Made under the COVID-19 Response and Economic Recovery Omnibus Act 2020 section 8 by the Acting Chief Executive Officer of the Department of Transport.

1. Citation

This order is the COVID-19 Response and Economic Recovery (Vessel Accommodation Fee Relief) Order 2021.

2. Commencement

This order comes into operation as follows-

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*;
- (b) the rest of the order—on the day after that day.

3. Terms used

In this order—

berthing due means the berthing due payable under regulation 6 of the Jetties Regulations;

berthing charge means a charge payable under regulation 72 of the Jetties Regulations;

eligible vessel means a commercial fishing vessel, commercial tourism vessel, or a commercial fishing and tourism vessel.

eligible owner means the owner of an eligible vessel on 1 April 2020;

fee relief amount means the total amount of any berthing dues and berthing charges paid in a 12 month period by the eligible owner of an eligible vessel between 1 January 2019 and 31 March 2020;

hiring fee means the hiring fee payable under regulation 7 of the MCA Regulations;

Jetties Regulations means the Jetties Regulations 1940;

MCA Regulations means the Shipping and Pilotage (Mooring Control Areas) Regulations 1983;

owner has the same meaning given in the Jetties Regulations regulation 3;

registered mooring site has the same meaning as it has in the MCA Regulations;

specified place has the same meaning as it has in the Jetties Regulations;

type of use has the same meaning as it has in Schedule 1 and 3 of the Jetties Regulations.

4. Swing mooring fee waived or reduced

- (1) Subject to subclause (2), a hiring fee is waived for a registered mooring site in Schedule 1.
- (2) If the eligible vessel of a registered mooring site in Schedule 1 is substituted with a different eligible vessel, the hiring fee is reduced by the amount that would have been waived under subclause (1).

5. Annual berthing due or charge waived or reduced

- (1) Subject to subclause (2), a berthing due or berthing charge is waived for the eligible vessel of an eligible owner at a specified place and for the type of use set out in Schedule 2.
- (2) The berthing due or berthing charge of an eligible vessel of an eligible owner is reduced by the amount that would have been waived under subclause (1) if—
 - (a) The eligible vessel in Schedule 2 is substituted with a different eligible vessel;
 - (b) The eligible vessel is berthed at a different specified place than that set out in Schedule 2; or
 - (c) The type of use by the eligible vessel is different than that set out in Schedule 2.

6. Seasonal berthing due or charge waived or reduced

- (1) An eligible vessel of an eligible owner has the fee relief amount specified in Schedule 3.
- (2) The berthing due or berthing charge is waived or reduced, as is appropriate in the circumstances, for an eligible vessel of an eligible owner, until the fee relief end date in Schedule 3, or until the fee relief amount is exhausted, whichever is earlier.

7. No refund

No part or whole of a hiring fee, berthing due, or berthing charge, is to be refunded under this order.

8. Order ceases to have effect

This order ceases to have effect at the end of 31 December 2021 unless revoked earlier.

ROAD TRAFFIC (VEHICLES) ACT 2012 ROAD TRAFFIC (VEHICLES) REGULATIONS 2014

DECLARATION THAT REGULATIONS 404 AND 406 DO NOT APPLY TO CERTAIN VEHICLES (RT(V)R-2020-203225)

- I, Hon. Rita Saffioti, Minister for Transport, acting pursuant to regulation 457 of the $Road\ Traffic\ (Vehicles)\ Regulations\ 2014$, hereby declare that regulations 404 and 406 do not apply to a pedalec tricycle—
 - (a) that does not exceed 1060 mm in overall width; and
 - (b) that is ridden by a person who has a licence agreement with Cycling Without Age Australia as to the use by him or her of Cycling Without Age Australia's intellectual property in relation to the carriage by him or her of passengers on the tricycle.

It is a condition of this declaration that any equipment or load on the tricycle does not exceed 1060 mm in overall width.

This declaration takes effect upon it being published in the *Government Gazette* and has effect for five years from then.
