#### BIOSECURITY AND AGRICULTURE MANAGEMENT REGULATIONS 2013

QUARANTINE AREA NOTICE REVOCATION

The Quarantine Area Notice—Bactrocera (Bactrocera) tryoni (Queensland fruit fly or Qfly) Coolbellup Outbreak, published in the Government Gazette WA on 2 February 2021 and in the West Australian Newspaper and on the Department of Primary Industries and Regional Development website is revoked and replaced by the following notice.

#### BIOSECURITY AND AGRICULTURE MANAGEMENT REGULATIONS 2013

QUARANTINE AREA NOTICE—BACTROCERA (BACTROCERA) TRYONI (QUEENSLAND FRUIT FLY)
Coolbellup Outbreak

1. Under regulation 60 of the *Biosecurity and Agriculture Management Regulations 2013* (Regulations) the area described below is declared to constitute a quarantine area until 18 June 2021. The area within a 15 kilometre radius of the intersection of Counsel Road and Coolbellup Avenue, Coolbellup.

**Note:** A map of the quarantine area will be published on the website of the Department of Primary Industries and Regional Development.

- 2. This quarantine area is declared because there are reasonable grounds to suspect the declared pest *Bactrocera* (*Bactrocera*) tryoni (Froggatt, 1897) (Queensland fruit fly or Qfly) may be present in the area.
- 3. In this notice—
  - "Department" means the Department of Primary Industries and Regional Development.
  - "Fruit" means the fruit of any host or suspect host of Queensland fruit fly listed in the table in Schedule 1.
  - "host plant" means a host or suspect host of Queensland fruit fly listed in the table in Schedule 1.

#### "outbreak area" means—

The area (within the quarantine area) bordered by and including west of Progress Drive, north of Bibra Drive, north of North Lake Road, north of Discovery Drive, north of Ambitious Link, west of Sudlow Road, north of Spearwood Avenue, east of Stock Road, north of Phoenix Road, east of Quickly Crescent, east of Southwell Crescent, south of Blackwood Avenue, west of Forrest Road, east of O'Connell Street, north of Hillier Crescent, east of Redmond Road, south of Winterfold Road, south east of the pedestrian walkway connecting Winterfold Road and Marchant Street, east of Marchant Road, south of McKenzie Road, east of the pedestrian walkway connecting McKenzie Road and Cumbor Way, east of Cumbor Way, south of the pedestrian walkway connecting Cumbor Way and Reveley Court, east of Reveley Court, south of Sowden Drive, east of Marshall Way, south of South Street, east of Cusack Way, south of Le Souef Drive, east of Clews Street, south of Riley Road, west of Battye Road, south of Le Souef Drive, west of North Lake Road, south of the northern border of the Kardinya Park shopping centre carpark, south of Brophy Street, west of Gilbertson Road, north west of Farrington Road.

- "wider quarantine area," means the part of the quarantine area that is not within the outbreak area.
- 4. Each person who is the owner or occupier of land within the outbreak area must ensure that any ripe or ripening fruit on plants and any fruit that has fallen to the ground from a plant on that land, is removed every 3 days and consumed or treated as set out in paragraph 5.
- 5. Fruit from plants within the outbreak area is to be treated by cooking (e.g. boiling or microwaving), freezing for a minimum of 24 hours, or solarisation (securing in a sealed black plastic bag which is placed on a hard surface in direct sunlight for a minimum period of 7 days).
- 6. Persons, other than persons employed by or on behalf of the Department, must not move any non-commercially produced fruit that was grown within the outbreak area, or any host plant with fruit attached that was grown within the outbreak area, from the outbreak area into the wider quarantine area, or from the quarantine area, except in accordance with
  - a. this notice; or
  - b. an approval under regulation 67 of the Regulations; or
  - c. a general exemption having effect under regulation 71 of the Regulations.

- 7. Non-commercially produced fruit grown within the outbreak area is moved in accordance with this notice if it is moved after being treated as set out in paragraph 5.
- 8. Host plants grown within the outbreak area are moved in accordance with this notice if all fruit has been removed from those host plants prior to movement.
- 9. Persons, other than persons employed by or on behalf of the Department, must not move any commercially produced fruit or host plants from the wider quarantine area, except in accordance with
  - a. this notice: or
  - b. an approval under regulation 67 of the Regulations; or
  - c. a general exemption having effect under regulation 71 of the Regulations.
- 10. Commercially produced fruit and commercially produced host plants are moved from the wider quarantine area to other areas within Western Australia in accordance with this notice if
  - a. the fruit has been processed; or
  - b. all fruit has been removed from the host plants prior to movement; or
  - c. the fruit or host plants
    - i. have been harvested, treated, prepared or packaged in accordance with measures approved by the Department's Chief Plant Biosecurity Officer; or
    - ii. were produced outside of the quarantine area and were securely packaged in accordance with measures approved by the Department's Chief Plant Biosecurity Officer while being transported through the quarantine area; or
    - iii. were sold in a retail outlet within the quarantine area; or
    - iv. are moved as authorised or directed by an inspector.

**Note**: measures approved by the Chief Plant Biosecurity Officer for the purposes of clause 10 will be published on the Department's website.

- 11. Fruit and host plants are moved from the quarantine area to areas outside Western Australia in accordance with this notice, if moved in accordance with the import requirements of the destination country or Australian State or Territory.
- 12. Each person, who is the owner or occupier of land in the quarantine area, is taken to have been given a quarantine notice that applies to that land in the terms of this quarantine area notice.
- 13. Failure to comply with this quarantine area notice could result in a fine, the Director General taking remedial action under regulation 133 of the Regulations, or both.

## FISH RESOURCES MANAGEMENT ACT 1994

SHARK BAY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993

Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery

Notice No. 1 of 2021

- I, Rick Fletcher, Executive Director of the Department of Primary Industries and Regional Development, Sustainability and Biosecurity, Western Australia, in accordance with clause 10 of the Shark Bay Prawn Managed Fishery Management Plan 1993, consider it in the better interest of the Shark Bay Prawn Managed Fishery (Fishery) to hereby—
  - 1. Cancel Notice of Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery: Notice No. 2 of 2020 dated 9 July 2020.
  - 2. Permit the trialling of gear between 0800 and 1600 hours each day from 17 March 2021 to 7 April 2021 provided no fish are held on board, or landed from, the authorised boat and from 7 April 2021 to 15 September 2021 provided the cod-end is open, in the area described as the Gear Trial Area in the Schedule to this Notice.
  - 3. Except as provided for under Clause 2 of this Notice, prohibit fishing for prawns in those parts of the Fishery, between the times and dates provided for in items (a) to (j) below—
    - (a) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 1 of 2021* to 0800 hours on 15 September 2021 in the following areas as described in the Schedule to this Notice
      - i. Withnell Point Closure;
      - ii. South Carnarvon Peron Line Closure.
    - (b) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 1 of 2021* to 1700 hours on 4 May 2021 and from 0800 hours on 24 May 2021 to 0800 hours on 15 September 2021 in the area defined as the *North Carnarvon Peron Line Closure* in the Schedule to this Notice.
    - (c) fishing for prawns is prohibited from the date of the gazettal of Notice No. 1 of 2021 to 1700 hours on 4 May 2021 in the area defined as the West Carnarvon Peron Line Closure in the Schedule to this Notice.
    - (d) fishing for prawns is prohibited from the date of the gazettal of Notice No. 1 of 2021 to 1700 hours on 4 June 2021 in the area defined as the Central Carnarvon Peron Line Closure in the Schedule to this Notice.
    - (e) fishing for prawns is prohibited from 0800 hours on 24 May 2021 to 1700 hours on 5 August 2021 in the area defined as the *Denham Sound Closure* in the Schedule to this Notice.
    - (f) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 1 of 2021* to 0800 hours on 24 May 2021 in the area defined as the *Snapper/Trawl Closure* in the Schedule to this Notice.
    - (g) fishing for prawns is prohibited from 1700 hours on 5 August 2021 to 0800 hours on 15 September 2021 in the area defined as the *Extended Snapper/Trawl Closure* in the Schedule to this Notice.

- (h) in parts of the Fishery within the area defined as *North of Koks Island* in the Schedule to this Notice where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 1000 hours and 1700 hours each day between the date of the gazettal of *Notice No. 1 of 2021* and 15 September 2021.
- (i) in parts of the Fishery within the area defined as *South of Koks Island* in the Schedule to this Notice where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 0800 hours and 1700 hours each day between the date of the gazettal of *Notice No. 1 of 2021* and 15 September 2021.
- 4. Except as provided for under Clause 2 of this Notice, fishing for prawns is prohibited in all parts of the Fishery outside of the fishing season which is from 1700 hours on 7 April 2021 to 0800 hours on 15 September 2021.

#### SCHEDULE 1

#### Gear Trial Area

The part of the Fishery bounded by a line commencing at a point at 24° 50′ south latitude and 113° 21.50′ east longitude; then extending due south along the meridian to a point at 24° 52.75′ south latitude and 113° 21.50′ east longitude; then due east along the parallel to a point at 24° 52.75′ south latitude and 113° 23.50′ east longitude; then due north along the meridian a point at 24° 50′ south latitude and 113° 23.50′ east longitude; then due west along the parallel to the commencement point.

#### Withnell Point Closure

The part of the Fishery bounded by a line commencing at point at 25° 36′ south latitude and 113° 01.63′ east longitude (on Dirk Hartog Island); then extending due east along the parallel to a point at 25° 36′ south latitude and 113° 03.75′ east longitude; then due south along the meridian to a point at 25° 38′ south latitude and 113° 03.75′ east longitude; then due west along the parallel to a point at 25° 38′ south latitude and 113° 02.29′ east longitude (on Dirk Hartog Island); then generally northerly along the high water mark to the commencement point.

#### South Carnarvon Peron Line Closure

The part of the Fishery bounded by a line commencing at a point at 25° 26′ south latitude and 113° 45.24′ east longitude; then extending due west along the parallel to a point at 25° 26′ south latitude and 113° 40′ east longitude; then north-westerly along the geodesic to a point at 25° 20.40′ south latitude and 113° 30.60′ east longitude; then due north along the meridian to a point at 25° 15.20′ south latitude and 113° 30.60′ east longitude; then due east along the parallel to a point at 25° 15.20′ south latitude and 113° 40.706′ east longitude; then south-easterly along the geodesic to the commencement point.

# North of Koks Island

The part of the Fishery north of 24° 45.30′ south latitude.

## South of Koks Island

The part of the Fishery south of 24° 45.30′ south latitude.

## North Carnarvon Peron Line Closure

The part of the Fishery bounded by a line commencing at a point at 24° 52.75′ south latitude and 113° 37.60′ east longitude (on Babbage Island); then extending due west along the parallel to a point at 24° 52.75′ south latitude and 113° 21′ east longitude; then due south along the meridian to a point at 24° 58.10′ south latitude and 113° 21′ east longitude; then south-easterly along the geodesic to a point at 25° 03′ south latitude and 113° 22.46′ east longitude; then due east along the parallel to a point at 25° 03′ south latitude and 113° 33.517′ east longitude; then northerly along the geodesic to a point at 24° 56.06′ south latitude and 113° 31.887′ east longitude; then due east along the parallel to a point at 24° 56.06′ south latitude and 113° 40.90′ east longitude (on the mainland); then generally north-westerly along the high water mark to the commencement point.

#### **Denham Sound Closure**

The part of the Fishery south of a line commencing at a point at 25° 32′ south latitude and 113° 29.74′ east longitude (on the mainland at Peron Peninsula); then extending due west along the parallel to a point at 25° 32′ south latitude and 113° 25′ east longitude; then westerly along the geodesic to a point at 25° 31.25′ south latitude and 113° 09.75′ east longitude; then westerly along the geodesic to a point at 25° 30′ south latitude and 113° 01.40′ east longitude (on Dirk Hartog Island at Cape Levillain); and in that part of the Fishery east of a line commencing at a point at 26° 07.30′ south latitude and 113° 10.90′ east longitude (on Dirk Hartog Island at Surf Point); then south-westerly along the geodesic to a point at 26° 08.62′ south latitude and 113° 09.60′ east longitude (on the mainland at Steep Point).

#### Snapper/Trawl Closure

The part of the Fishery south of a line commencing at a point at 25° 40.59′ south latitude and 113° 02.87′ east longitude (on Dirk Hartog Island); then extending due east along the parallel to a point at 25° 40.59′ south latitude and 113° 04.80′ east longitude; then south-easterly along the geodesic to a point at 25° 41′ south latitude and 113° 08′ east longitude; then south-easterly along the geodesic to a point at 25° 46′ south latitude and 113° 13′ east longitude; then due east along the parallel to a point at 25° 46′ south latitude and 113° 19′ east longitude; then due north along the meridian to a point at 25° 38′ south latitude and 113° 19′ east longitude; then north-easterly along the geodesic to a point at 25° 32′ south latitude and 113° 25′ east longitude; then due east along the parallel to a point at 25° 32′ south latitude and 113° 29.74′ east longitude (on the mainland at Peron Peninsula); and in that part of the Fishery east of a line commencing at a point at 26° 07.30′ south latitude and 113° 19′ east longitude (on the mainland at Peron Peninsula) to a point at 26° 07.30′ south latitude and 113° 19′ east longitude (on the mainland at Peron Peninsula); and in that part of the Fishery east of a line commencing at a point at 26° 07.30′ south latitude and 113° 19′ east longitude (on the mainland at Steep Point).

# **Extended Snapper/Trawl Closure**

## SALARIES AND ALLOWANCES ACT 1975

VARIATION TO MEMBERS OF PARLIAMENT TRIBUNAL DETERMINATION NO. 1 OF 2020

#### Preamble

- (1) The Salaries and Allowances Tribunal issues this Variation to make minor adjustments to the *Members of Parliament Tribunal Determination No 1 of 2020* (the Determination), issued on 14 December 2020.
- (2) The Determination introduced significant changes that will commence after the State Election on 13 March 2021 and aim to improve transparency and accountability regarding the use of allowances provided to Members.
- (3) This Variation addresses matters raised through feedback provided to the Tribunal by administering agencies and Members of Parliament.
- (4) This Variation establishes transitional administrative arrangements for the introduction of the Members Allowance and clarifies that—
  - (a) annual reporting on use of the Members Allowance will commence with expenditure undertaken in the 2021-22 financial year; and
  - (b) the Air Charter Allowance may, subject to prior approval from the Tribunal, be used by Members for other modes of transport when aircraft are not available.
- (5) The variation also updates the Members Allowance reporting form, at Appendix 1.

The Variation will now issue.

#### SALARIES AND ALLOWANCES TRIBUNAL

#### **DETERMINATION VARIATION**

The Members of Parliament Tribunal Determination No 1 of 2020, issued on 14 December 2020, under sections 6(1)(a), (ab), (b) and 6AA of the Salaries and Allowances Act 1975, is hereby varied by a determination set out below.

The variation is effective on and from 14 March 2021.

# **VARIATION 1**

# In the definition of the term "Parliamentary business" in 1.5, delete (b) and insert—

- (b) excludes—
  - (i) campaigning, such as attending or organising
    - i. campaign launches;
    - ii. candidate selection or campaign strategy meetings; and
    - iii. general campaigning on behalf of election candidates; and
  - (ii) Party political activity, including
    - i. campaigning for a political Party; and
    - ii. organising and sustaining Party branches, such as recruiting Members to the Party or undertaking administrative activities to support the Party; and
  - (iii) the publication, broadcasting, display or distribution of material intended to, calculated or likely to affect voting in an election.

# **VARIATION 2**

# Delete 3.1 and insert the following—

#### 3.1 General

- (1) An Allowance in this Part is claimed on a quarterly basis to meet expenses related to the Member's Parliamentary business, including expenses for—
  - (a) information and communication technology, including mobile phone use, newsletters and internet publications;
  - (b) awards and support for community groups or individuals;
  - (c) hospitality associated with a Member's Parliamentary business;
  - (d) advertising, other than for the purposes of campaigning, electioneering or political party promotion;
  - (e) safety equipment for motor vehicles;
  - (f) costs associated with Electoral Management Systems; and
  - (g) stationery and printing; and other expenses related directly to Parliamentary business.
- (2) The Allowance may be used at the Member's discretion, within the parameters set in this Determination.

Amounts that can be claimed

(3) Subject to 3.1(4) and 3.1(5), a Member may claim each quarter up to a maximum of 25% of the annual amount available to the Member.

- (4) In the event a Member does not claim the full amount of the Allowance in one quarter, a sum equivalent to the unclaimed amount may be claimed in a later quarter in the same year, in addition to the amount in 3.1(3).
- (5) In the event a Member does not claim the full amount of the Allowance in one year, a sum equivalent to the unclaimed amount, up to a maximum of 10% of the Member's annual Allowance, will be preserved for use in the following year.
- (6) The preserved amount in 3.1(5)—
  - (a) is available in addition to the Member's usual annual allocation;
  - (b) can be claimed in any quarter in the subsequent financial year, in addition to the allowances available under 3.2 and 3.3; and
  - (c) is foregone at the end of the year subsequent to the year in which it was provided.

#### Claim process

- (7) A Member's claim of a quarterly amount of an Allowance in this Part must—
  - (a) include certification by the Member that use of the Allowance will be consistent with the principles set out in 1.6(1);
  - (b) specify the amount that is being claimed; and
  - (c) comply with conditions set in 3.1(8).
- (8) A Member's claim for a quarterly amount must be provided to the administering authority no later than—
  - (a) 30 June, for the period from 1 July to 30 September (for payment in the end of July payroll run);
  - (b) 30 September, for the period from 1 October to 31 December (for payment in the end of October payroll run);
  - (c) 31 December, for the period from 1 January to 31 March (for payment in the end of January payroll run); and
  - (d) 31 March, for the period from 1 April to 30 June (for payment in the end of April payroll run).
- (9) In exceptional circumstances, such as ill health and bereavement, a Member may apply to the administering agency to submit a claim that does not comply with 3.1(8).
- (10) When considering exceptional circumstances under 3.1(9), administrative oversight or negligence are not relevant considerations for the administering agency.
- (11) An application under 3.1(9) must be in writing and must provide sufficient details of the exceptional circumstances.

#### Members serving part of a Parliamentary term

- (12) A Member who serves part of the period between dates specified in 3.1(8) may claim and be provided an amount for that period calculated on a pro rata basis.
- (13) With the exception of a Member who ceases to be a Member at the end of a Parliamentary term, a Member who—
  - (a) ceases to be a Member between dates specified in 3.1(8); and
  - (b) has been provided a quarterly amount for that period;
- will be required to repay a proportion of the amount provided to them, calculated on a pro-rata basis for the period served.

# Reporting

- (14) Use of this Allowance must be reported to the Tribunal annually, with expenditure reported in aggregate terms according to categories set out at Appendix 1 to this Determination.
- (15) The first annual report under 3.1(14) is to report the Member's expenditure undertaken during the 2021-22 financial year.
- (16) The annual report must include the Member's certification, in the form set out in Appendix 1, that expenditure has complied with the—
  - (a) conditions of use set out for the Allowance; and
  - (b) principles stated in 1.6.
- (17) The annual report must identify amounts of the Allowance that were—
  - (a) drawn down by the Member and not expended for the purposes set out in this Part; and
  - (b) not drawn down by the Member.

## Transitional arrangements

(18) For transitional administrative purposes, an Allowance under this Part may be provided on a monthly or twice-monthly basis in the period from the day this Part commences to 30 June 2021.

# **VARIATION 3**

# Delete 4.3(6) and insert the following—

- (6) This Allowance may be used by Members—
  - (a) to charter aircraft under commercial arrangements;

- (b) who, after receiving prior approval from the Tribunal, use-
