ENERGY COORDINATION ACT 1994

APPROVAL OF AMENDMENTS TO THE WESTERN AUSTRALIAN GAS RETAIL MARKET SCHEME—IN003/20W, IN002/15W, IN009/19W AND IN010/20W

The Economic Regulation Authority (ERA), pursuant to section 11ZOM of the *Energy Coordination Act 1994*, hereby gives notice regarding the following amendments to the Western Australian gas retail market scheme—

- IN003/20W: This proposal adds two transactions to market participants' information technology systems to allow retailers and the network operator to exchange information regarding customer contact details for the purpose of conducting site works.
- IN002/15W: This proposal adds two transactions to market participants' information technology systems to allow retailers and the network operator to exchange information regarding a customer's meter disconnection or reconnection.
- IN009/19W and IN010/20W: These proposals amend several transactions to add further information regarding the status of a customer's meter.

These proposals were submitted to the ERA for approval by the Australian Energy Market Operator (AEMO). Pursuant to section 11ZOM(a) of the *Energy Coordination Act 1994* (WA), the ERA approves the amendments in procedure change proposals IN003/20W, IN002/15W, IN009/19W and IN010/20W as submitted by AEMO.

Pursuant to rule 386(a) of the Retail Market Procedures (WA), the amendments will take effect on a date specified by the ERA. AEMO has requested that the amendments take effect on Monday 29 November 2021. This will allow AEMO and market participants adequate time to conduct system upgrades and publish the amended technical protocol documents in the Specification Pack by the effective date.

The amendments to the Western Australian gas retail scheme as outlined in procedure change proposals IN003/20W, IN002/15W, IN009/19W and IN010/20W will therefore take effect from Monday 29 November 2021.

1. Citation

This instrument is the West Coast Rock Lobster Managed Fishery Management Plan Amendment 2021.

2. Management plan amended

The amendments in this instrument are to the West Coast Rock Lobster Managed Fishery Management Plan 2012.

3. Commencement

- (b) have any rock lobster on board an authorised boat unless the total quantity of rock lobster taken under the authority of the licence in the Zone fished on that trip is less than or equal to the product of the current entitlement for the Zone in which rock lobster were taken and the relevant unit value; or
- (c) take, land, consign or sell rock lobsters unless the total quantity of rock lobster taken under the authority of the licence in the Zone fished on that trip is less than or equal to the product of the current entitlement for the Zone in which rock lobster were taken and the relevant unit value.

8. Clause 51 amended

In clause 51(3)(c)(ii) delete "weight " and insert—quantity

9. Clause 67B inserted

Following clause 67 insert—

67B. Transitioning pots between different Zones

- (1) Notwithstanding clause 67, the master of an authorised boat may, with the written approval of a Fisheries Officer, have pots in more than one Zone of the Fishery for the purpose of transferring pots from one Zone to another Zone.
- (2) A person must not pull pots from more than one Zone of the Fishery during the period specified in any written approval provided under subclause (1).

10. Clause 72B replaced

Delete clause 72B and insert—

72B. Prohibitions in respect of back of boat lobsters

- (1) A person must not—
 - (a) sell, consign, or attempt to sell or consign, back of boat lobsters to a registered receiver;
 - (b) receive a consignment of back of boat lobsters in a registered receiver's premise.
- (2) A registered receiver must not purchase back of boat lobsters.
- (3) The master of an authorised boat must not land back of boat lobsters unless a pre-landing nomination form is submitted to the Department using Fish Eye, in accordance with clause 35.

Delete Schedule 8 and insert-

SCHEDULE 8—Unit values

[clause 18]

1. The extent of the entitlement to fish in a Zone of the Fishery arising from a unit during a licence period is determined in accordance with the following formula—

$$\begin{pmatrix} A \\ B \end{pmatrix} \times 101.5\% = C$$

Where—

- A is the capacity (whole weight of rock lobster) of the relevant Zone;
- B is—
 - (i) for the licence period ending 30 June 2021—the sum of all of the units conferred for that Zone, as specified on all the relevant licences immediately before the expiry of the relevant licensing period, subject to clause 23;
 - (ii) for any licence period other than as specified in (i)—the figure specified in the Table to this Schedule for that respective Zone;
- C is the value of the unit (incorporating water loss factor).
