1 Section 4

Insert:

quad bike dealer means a person who buys and sells quad bikes in the course of a business carried on by the person.

2 Section 14

Before "General", insert "(1)".

3 Section 14

After "quad bikes", insert "(other than a general use quad bike covered by the exception in subsection (2))".

4 At the end of section 14

Add:

- (2) The exception in this subsection covers a general use quad bike if:
 - (a) a quad bike dealer placed an order for it before 1 July 2021; and
 - (b) the order was not subject to a condition that the general use quad bike be supplied to the dealer after 31 December 2021.
