FIREBREAK NOTICE

Notice to all landowners and occupiers of land in the City of Bayswater.

All landowners and occupiers of land within the City of Bayswater are advised that, on or before the 1 November 2021 or within fourteen days of the date of becoming an owner or occupier up to and including 31 March 2022 must ensure compliance with the following firebreak conditions—

All land which is 2000 square metres or less in area—

Remove all inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm

All other land within the City of Bayswater-

i. Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;

ii. Firebreaks of a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept.

If for any reason an owner and/or occupier consider it impractical to clear firebreaks or comply with other fire protection measures in accordance with this Notice, the owner and/or occupier may apply in writing to Council not later than 31 October 2021.

Where an owner and/or occupier of land fails or neglects to comply with any requirement of this Notice, Council may undertake the work and recover the costs and expenses from the owner and/or occupier pursuant to the Act, in addition to any penalty which might be imposed. A Penalty of not more than \$5,000 applies.

Burning off within the City of Bayswater is prohibited. All clearing and disposal of waste should be carried out by methods other than burning.

- Clean gutters on all buildings
- Remove debris from around buildings
- Maintain a 20-metre low fuel zone around all habitable buildings.

Residential properties

- Grass must not be higher than 10cm.
- Residential properties larger than 2024m<sup>2</sup>
  - Maintain a 3-metre-wide firebreak on all external boundaries.
  - You can manage your entire property as a low fuel zone instead of installing firebreaks.

## Special rural properties

- Maintain a 3-metre-wide firebreak on all external boundaries
- Rural properties
  - Maintain a 20-metre-wide low fuel zone or 2 metre firebreak around all haystacks.
  - Maintain a 2-metre-wide firebreak on land adjacent to a road reserve.

#### Plantations

Adhere to the Guidelines for Plantation Fire Protection 2011.

## Specifications

Low fuel zone

To maintain a low fuel zone, you must-

- reduce and maintain fuel loads at 2 tonnes per hectare
- skirt trees up to a height of 2m
- no trees/shrubs over 2 metres high within 2 metres of a habitable building
- no tree crowns/branches over habitable buildings
- clear/prune scrub to reduce to a sparse density—you must be able to walk through with relative ease and minimal deviation
- no grass higher than 10cm.

#### Firebreak

Your firebreaks must—

- be as close as practical to the property boundary
- have a vertical clearance height of 4 metres (excludes rural zoned properties)
- be continuous and trafficable for a 4WD vehicle with no obstructions
- mineral/bare earth—clear of all vegetation—
- not terminate in a dead-end.

Maintained green lawns are acceptable in conjunction with or instead of mineral earth firebreaks. They must meet the firebreak clearance and width requirements.

## PUBLIC SECTOR MANAGEMENT ACT 1994 SEPARATION SCHEME DEPARTMENT OF COMMUNITIES APPROVED BY THE MINISTER

Pursuant to regulation 16 of the *Public Sector Management (Redeployment and Redundancy) Regulations 2014* (the Regulations), I, Mark McGowan, Premier; Minister for Public Sector Management, hereby approve a scheme, under which employees of the Department of Communities or Disability Services Commission are invited to apply to be offered voluntary severance, as follows—

- the scheme shall apply to all eligible Department of Communities or Disability Services Commission employees under the *Public Sector Management Act 1994* and the Regulations;
- the scheme shall provide for the employing authority to make an offer of a voluntary severance to an eligible employee;

- a \$500 payment for each employee who accepts a voluntary severance to be paid on separation;
- the period within which an application under the scheme may be made will be up to and including 31 December 2021; and
- applications made, as provided above, may only be accepted on the basis that the employee exits the public sector no later than 31 December 2021.
