SPEED BOATS AND WATER-SKIING AREA High Speed Commercial Water Sports Area Perth Waters, Swan River

> Department of Transport Fremantle WA, 10 August 2021

Acting pursuant to the powers conferred by Regulation 48A of the *Navigable Waters Regulations 1958*, I hereby cancel section MH404 (1)(b)(1)(x) as published in the *Government Gazette* on 25 October 1991 and hereby set aside the following area of water for parasailing, water skiing and speed boat racing.

LOCATION: Those waters of the Swan River east of the Narrows Bridge bounded by a line commencing 50 metres from the bridge and 50 metres from the South Perth foreshore at approximately 31°57.847′S, 115°50.860′E; thence approximately 220 metres north-easterly to the navigation marker at approximately 31°57.784′S, 115°50.979′E; thence approximately 260 metres north-easterly to the navigation marker at approximately 31°57.731′S, 115°51.130′E; thence approximately 410 metres east-south-easterly to the navigation marker at approximately 31°57.770′S, 115°51.386′E; thence approximately 760 metres south-south-westerly alongside of the Mends Street Channel to the navigation marker at approximately 31°58.165′S, 115°51.239′E; thence northwesterly 470 metres to 31°57.981′S, 115°51.030′E (north of the Jetty adjacent Queen Street); thence parallel to the foreshore at a distance of 50 metres in a north-westerly direction to the point of commencement. All coordinates in GDA94.

Providing however, any vessel operating in the above area holds a current permit from the Department of Biodiversity Conservation and Attractions to conduct such activities or is a bonified vessel participating in an event that is approved by the Department of Transport under Regulation 51C of the Navigable Waters Regulations 1958; and

Excluding those waters within 50 metres of a mooring or vessel secured to a mooring.

RESTRICTED SPEED AREA Perth Water Swan River, Perth

> Department of Transport Fremantle WA, 10 August 2021

Acting pursuant to the powers conferred by Section 67 of the Western Australian Marine Act 1982, I hereby cancel notice MA406 as published in the Government Gazette 23 January 2018 and limit the speed of all motorised vessels to eight (8) Knots within the following area—

LOCATION; Those waters of the Swan River bounded by a line commencing at 31°57.621′S, 115°51.751′E (on the foreshore approximately 260 metres east of the West Australian Rowing Club boatshed); thence to the navigation marker at 31°57.714′S, 115°51.722′E (approximately 185 metres south-south-westerly); thence along the line of the southern boundary of the navigation channel to where this intersects Heirisson Island at approximately 31°58.007′S, 115°52.611′E; thence along the western shore of Heirisson Island to a point approximately 31°58.121′S, 115°52.555′E; thence approximately 420 metres south-westerly to the South Perth foreshore at 31°58.261′S, 115°52.347′E; thence westerly along the South Perth foreshore to 31°57.879′S, 115°50.750′E (50 metres west of the Narrows Bridge); thence across the Swan River parallel to the bridge to the Mounts Bay foreshore at 31°57.747′S, 115°50.774′E; thence generally easterly along the foreshore to the starting point; but excluding the 5 knot speed restriction area at Elizabeth Quay. All coordinates based on GDA94.

Providing however this notice does not apply to the following—

Seaplanes whilst taking off and landing within Perth Waters south of Riverside Drive, east of the Mends Street and north of the Coode Street navigational channels;

Commercial high-speed vessels operating in accordance with a permit to operate issued by the Department of Biodiversity Conservation and Attractions; and

All Public Transport Authority Ferries operating from Mends Street Jetty to Elizabeth Quay where these ferries may exceed the 8 knot limit to a maximum speed of 12 Knots within the following areas:

When transiting to Elizabeth Quay—from the intersection of navigational aids 857 (Starboard) and 1034 (Port) at the Mends Street end to adjacent starboard navigational aid 855; and

When transiting to the Mends Street Jetty—from adjacent to the port navigational aid 1031 to the intersection of navigational aids 857 (Starboard) and 1034 (Port).

PERSONAL WATERCRAFT (PWC)
PWC Freestyle Driving
Swan River and Canning Rivers

Department of Transport Fremantle WA, 10 August 2021

Acting pursuant to the powers conferred by Section 50A of the *Navigable Waters Regulations 1958*, I hereby cancel Notice MA402 as published in the *Government Gazette* on 12 December 2014 and prohibit the practices of personal watercraft freestyle driving, wave jumping and surfing in the Swan and Canning Rivers, with the exception of the following areas—

Narrows—Personal Watercraft (PWC) Freestyle Driving Area: All waters bounded by the shore and a line commencing at 31°58.010′S, 115°50.690′E (on the shore adjacent the Mill Point boat ramp); thence south-westerly 790 metres to the Quarry Spit Starboard Beacon No. 1 at approximately 31°58.270′S, 115°50.291′E; thence southerly approximately 1100 metres to 31°58.866′S, 115°50.282′E; thence north-easterly approximately 1225 metres to 31°58.340′S, 115°50.755′E; thence northerly approximately 470 metres to 31°58.088′S, 115°50.720′E (on the end of the second groyne south from the Narrows). All coordinates based on GDA 94.

Perth Waters—High Speed Commercial Water Sports area: Those waters of the Swan River east of the Narrows Bridge bounded by a line commencing 50 metres from the bridge and 50 metres from the South Perth foreshore at approximately 31°57.847′S, 115°50.860′E; thence approximately 220 metres north-easterly to the navigation marker at—

Approximately 31°57.784′S, 115°50.979′E; thence approximately 260 metres north-easterly to the navigation marker at

Approximately 31°57.731′S, 115°51.130′E; thence approximately 410 metres east-south-easterly to the navigation marker at approximately 31°57.770′S, 115°51.386′E; thence approximately 760 metres south-south-westerly alongside of the Mends Street Channel to the navigation marker at approximately 31°58.165′S, 115°51.239′E; thence North-westerly 470 metres to 31°57.981′S, 115°51.030′E (north of the Jetty adjacent Queen Street); thence parallel to the foreshore at a distance of 50 metres in a north-westerly direction to the point of commencement. All coordinates in GDA94.

Providing however only PWC that hold a current permit from the Department of Biodiversity Conservation and Attractions to conduct such activities or is a bonified vessel participating in an event that is approved by the Department of Transport under Regulation 51C of the *Navigable Waters Regulations 1958* and abides by all associated aquatic event approval conditions may operate within the High Speed Commercial Water Sports Area.
