- (b) A decision about a clearing matter in respect of clearing that is the result of carrying out an activity referred to in (a)(i) or (a)(ii) above must not be made unless—
  - (i) the authority or requirement under which the activity is to take place has been granted or imposed; or

(ii) an application for the authority has been refused.

In this delegation—

"clearing matter" means-

- (a) a referral of proposed clearing made under section 51DA of the Act; or
- (b) an application for a clearing permit made under section 51E of the Act; or
- (c) an application to amend a clearing permit made under section 51KA of the Act; or

(e) a notification of change of land ownership and request to transfer an area permit made under section 51N of the Act.
