3. City of Greater Geraldton Public Places and Local Government Property Local Law 2020 amended

- (1) In this local law the City of Greater Geraldton Public Places and Local Government Property Local Law 2020 as published in the Government Gazette on 5 January 2021 is referred to as the principal local law.
- (2) In clause 1.5 of the principal local law the definition of 'authorised person' is replaced with—

 authorised person means a person appointed by the CEO under section 9.10 of the Act to perform any of the functions of an authorised person under this local law;
- (3) Clause 5.5 of the principal local law is deleted and replaced with—
 - 5.5 Leaving animal or vehicle in public place

- (1) A person must not leave an animal or a vehicle, or any part of a vehicle, in a public place so that it obstructs the use of any part of that public place, unless that person has first obtained a licence or is authorised to do so under a written law.
- (2) A person does not contravene subclause (1) where the animal is secured or tethered for a period not exceeding 1 hour.
- (3) A person does not contravene subclause (1) where the vehicle is left for a period not exceeding 24 hours.
- (4) In clause 7.1 of the principal local law the definitions of 'protected fauna' and 'rare fauna' are deleted and replaced with the following—

protected flora has the meaning given to it in Part 10, Division 2 of the Biodiversity Conservation Act 2016;

rare flora has the meaning given to it in Regulation 168 of the Biodiversity Conservation Regulations 2018;

"Independent living complex" means a development with self-contained, independent dwellings for aged or dependent persons together with communal amenities and facilities for residents and staff that are incidental and ancillary to the provision of such accommodation, but does not include a development which includes these features as a component of a residential aged care facility.
