#### **ENVIRONMENTAL PROTECTION ACT 1986**

Section 19

#### **DELEGATION NO. 54**

The Environmental Protection Authority ("Authority"), acting pursuant to section 19 of the *Environmental Protection Act 1986* ("the Act"), has resolved to delegate all its powers and duties conferred or imposed by—

- a. section 17(3)(b) of the Act save that these powers and duties may only be exercised in circumstances where an implementation condition provides for the Authority's advice to be given to the Minister for Environment on a matter relating to the implementation of the proposal;
- b. sections 38A, 38C, 38F, 38G, 38H, 38I, 39, 40(2)(a), 40(2)(b), 40(2a), 40(3), 40(4), 40(5), 40(6)(b), 40A, 41A, 43A, 48A and 48C of the Act;
- c. regulations 3B and 3D of the Environmental Protection Regulations 1987;
- d. any request received by the Authority from the Appeals Convenor to report on an appeal under section 106(1)(a) of the Act, including the preparation and submission of a report to the Minister on the appeal;
- e. sections 44(1) and 44(2a) of the Act save that these powers and duties may only be exercised in circumstances where the Authority has resolved that, a person to whom this delegation applies, should prepare and approve the final report and give that report to the Minister;
- f. section 46 of the Act, including s46(4) save for exercising the discretion under s46(4) in relation to the decision as to whether or not to inquire into implementation conditions relating to a proposal declared a derived proposal under s38E of the Act;
- g. section 48D (1) of the Act save that these powers and duties may only be exercised in circumstances where the Authority has resolved that, a person to whom this delegation applies, should prepare and approve the final report and give that report to the Minister.

Pursuant to section 59(2) of the *Interpretation Act 1984* the delegation of the powers referred to in the sections of the Act listed above shall be deemed to include the delegation of any duty incidental thereto or connected therewith.

Persons to whom this delegation applies-

- a. The Chair of the Authority appointed under s7(4a) of the Act;
- b. The Deputy Chair of the Authority appointed under s7(4a) of the Act on the conditions that the delegation is only exercised by the Deputy Chair when the Chair is unable to exercise the delegation either because of an absence (including, but not limited to on business, on leave or vacancy of office) or due to a conflict of interest.

Pursuant to section 19 of the Act and section 59(1)(e) of the *Interpretation Act 1984*, Delegation No. 50 dated 26 October 2021 and published in the *Gazette* on 29 October 2021 is hereby revoked.

- g. section 48C(5)(b) of the Act to require the responsible authority to respond to any submissions made in respect of the report provided in compliance with section 48C(1)(a) of the Act and made available for public review.

Pursuant to section 59(2) of the *Interpretation Act 1984* the delegation of the powers referred to section above shall be deemed to include the delegation of any duty incidental thereto or connected therewith.
