LOCAL GOVERNMENT ACT 1995 *Mindarie Regional Council*

WASTE FACILITY SITE AMENDMENT LOCAL LAW 2022

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Mindarie Regional Council resolved on 24 November 2022 to make the following local law.

1. Title Citation

This local law may be cited as the *Mindarie Regional Council Waste Facility Site Amendment Local Law 2022*.

2. Commencement

This local law will come into operation 14 days after the day on which it is published in the *Government Gazette*.

3. Principal Local Law Amended

This local law amends the *Mindarie Regional Council Waste Facility Local Law 2012*, as published in the *Government Gazette* on 11 May 2012 and as amended in the *Government Gazette* on 15 March 2013 and 12 February 2021.

- (c) Item 20 is deleted.
