- b. the document is signed on behalf of the WAPC by a member or officer of the WAPC so authorised by the WAPC.

Under section 24(4) of the Act, the WAPC may authorise an officer as officer of the WAPC to affix the common seal of the WAPC and attest that act, either generally or in any particular case.

Under section 24(5) of the Act, the WAPC may, by writing under its common seal, authorise an officer or officers of the WAPC to sign documents on behalf of the WAPC, either generally or subject to such conditions or restrictions as are specified in the authorisation.

#### Resolution under section 24 of the Act (Authorisation)

On 31 May 2023, pursuant to section 24 of the Act, the WAPC resolved—

- A. TO AMEND the WAPC Authority to Affix Seal and to Sign Documents dated 22 May 2012, as set out in Schedule 1 below.
- B. TO PUBLISH a consolidated instrument.
