NOTICE OF AREAS CLOSED TO FISHING FOR PRAWNS IN THE

SHARK BAY PRAWN MANAGED FISHERY

Notice No. 4 of 2023

I, Rick Fletcher, Executive Director Fisheries and Agriculture Resource Management of the Department of Primary Industries and Regional Development, Western Australia, in accordance with clause 10 of the *Shark Bay Prawn Managed Fishery Management Plan 1993*, consider it in the better interest of the Shark Bay Prawn Managed Fishery (Fishery) to hereby—

- 1. Cancel Notice of Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery: Notice No. 3 of 2023 dated 10 May 2023.
- 2. Permit the trialling of gear between 0800 and 1600 hours each day from 25 March 2023 to 16 April 2023 provided no fish are held on board, or landed from, the authorised boat and from 16 April 2023 to 22 October 2023 provided the cod-end is open, in the area described as the **Gear Trial Area** in the Schedule to this Notice.
- 3. Except as provided for under Clause 2 of this Notice, prohibit fishing for prawns in those parts of the Fishery, between the times and dates provided for in items (a) to (d) below—
 - (a) fishing for prawns is prohibited from the date of the gazettal of Notice No. 4 of 2023 to 0800 hours on 22 October 2023 in the following areas defined in the Schedule to this Notice
 - i. Withnell Point Closure
 - ii. Red Cliff Point Closure
 - iii. South Carnarvon Peron Line Closure
 - iv. North Carnarvon Peron Line Closure
 - v. Extended Snapper/Trawl Closure
 - vi. Snapper/Trawl Closure
 - (b) fishing for prawns is prohibited from 0800 hours on 1 June 2023 to 1700 hours on 12 August 2023 in the area defined as the **Denham Sound Closure** in the Schedule to this Notice.
 - (c) in parts of the Fishery within the area defined as *North of Koks Island* in the Schedule to this Notice where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 1000 hours and 1700 hours each day between the date of the gazettal of *Notice No. 4 of 2023* and 22 October 2023.
 - (d) in parts of the Fishery within the area defined as *South of Koks Island* in the Schedule to this Notice where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 0800 hours and 1700 hours each day between the date of the gazettal of *Notice No. 4 of 2023* and 22 October 2023.
- 4. Except as provided for under Clause 2 of this Notice, fishing for prawns is prohibited in all parts of the Fishery outside of the fishing season which is from 1700 hours on 15 April 2023 to 0800 hours on 22 October 2023.

 - (5) Service Commercial:—
 - Subdivision and development in the Service Commercial zone shall comply with the following standards and requirements—

Lot size and setbacks

- (a) The Minimum lot size in the Service Commercial zone is 3,000 m².
- (b) The primary street setback in the Service Commercial zone is 4 metres, or as otherwise in accordance with an approved Local Development Plan.
- (c) The secondary street setback in the Service Commercial zone is 2 metres, or as otherwise in accordance with an approved Local Development Plan.
- (d) The side / rear setback in the Service Commercial zone shall be as determined by the local government, or as otherwise in accordance with clause 5(e) below.
- (e) The minimum setback between a building in the Service Commercial zone and any boundary shared with an adjacent Residential zoned lot shall be 3 metres or half the height of the wall facing that boundary, whichever is greater.

Use of setback areas

(f) In the Service Commercial zone no use of the area between the street alignment and the primary street setback line shall be permitted other than for landscaping, pedestrian or vehicular circulation, and vehicle parking in accordance with the provisions of the Scheme, except that am area up to 25 percent of the building setback area may be used for trade display purposes with the approval of the local government.

Floor space restrictions

(g) In the Service Commercial zone development on each lot (including a strata or survey strata lot) shall achieve a building with a floor area not less than 200m² NLA, unless otherwise approved by the local government.

Movement network, lot access and parking

- (h) Planning proposals in the Service Commercial zone shall establish a functional movement network, including vehicular access locations, consistent with the requirements of State road planning policy.
- (i) The location of crossovers in the Service Commercial zone shall be as determined by the local government, or as otherwise in accordance with an approved Local Development Plan.
- (j) In the Service Commercial zone suitable manoeuvring space shall be provided so that all vehicles can enter and exit the site in a forward gear. The local government may require lodgement of a truck movement plan as part of any development application.
- (k) Lot access, off-street parking and vehicle manoeuvring spaces in the Service Commercial zone shall comply with the following standards
 - i. Adequate off-street car parking shall be provided to cater for the projected volume of employees and customers as required by the local government.
 - ii. Adequate space for parking, loading and unloading of trade and service vehicles shall be provided as required by the local government.
 - iii. All off-street parking, loading and unloading areas shall be constructed, sealed and drained as required by the local government.

Other development requirements

- (l) Unless otherwise approved by the local government, buildings in the Service Commercial zone shall generally be orientated to the primary street, or as otherwise in accordance with an approved Local Development Plan.
- (m) In the Service Commercial zone a minimum 1 metre wide landscaping strip shall be provided along any highway or street frontage excluding any crossovers.
- (n) The use of zincalume or reflective materials is not permitted for the construction of new buildings.

Lot specific subdivision and development requirements

- (o) The subdivision and / or development of Lot 889 on DP 416835 shall comply with the following standards and requirements
 - i. The local government or Western Australian Planning Commission may require an urban water management plan to be prepared and approved, in consultation with the relevant State agency, to support any subdivision or development application.
