MA401**WESTERN AUSTRALIAN MARINE ACT 1982****APPROVAL AND EXEMPTION FROM COMPLIANCE WITH CERTAIN SPEED RESTRICTIONS FOR CERTAIN VESSELS UNDER THE CONTROL OF A BONA FIDE MEMBER OR EVENT OFFICIAL OF A YACHTING WESTERN AUSTRALIA (INC) AFFILIATED CLUB**

(WAMA—2023—206371)

I, Peter Beattie, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982* (the Act) and regulation 48(a) of the *Navigable Waters Regulations 1958* (the Regulations), hereby make the exemptions, approval and conditions set out below in relation to motorised vessels under the control of a bona fide member or event official of a club affiliated to Yachting Western Australia (Inc.) (YWA Vessels) whilst operating within the following areas only—

1. Belmont waterski area to Fremantle Traffic Bridge on the Swan River; and
2. Salters Point upstream to Shelley Bridge on the Canning River.

Exemptions

YWA Vessels are exempt from compliance with—

- regulations 48(c), 48(d)(i) and 48(d)(iv) of the Regulations; and
- notices made under section 67 of the Act and published in the *Government Gazette*.

Approval

YWA Vessel are granted approval to exceed the speed limit in accordance with regulation 48(a)(i) of the Regulations.

Conditions

The exemptions and approval listed above are subject to the following conditions—

1. Exceedance of the speed limit is—
 - a. only to the extent as is reasonably necessary to effectively undertake either—
 - i. safety, coaching or umpiring activities during an aquatic event as listed in the Yachting Western Australia (Inc.) calendar; or
 - ii. training organised by Yachting Western Australia (Inc.) for such an event,
 - b. not in excess of 12 knots over the speed limit that would apply but for this instrument.
2. DoT is in receipt of a safety management plan/s which covers all events listed in the Yachting Western Australia (Inc.) calendar, which addresses issues including—
 - a. conducting events in areas of high traffic density; and
 - b. the provision of appropriate training for vessel operators and crew to ensure that they are suitably experienced in navigating whilst operating at high speed (including when undertaking emergency response), and that they take reasonable care in all circumstances.
3. The Vessels display the word 'Safety' in letters at least 200mm high and 20mm thick, either on both sides of the hull, or in red writing on a white flag.
4. A copy of this instrument is produced to DoT as soon as possible upon request.

This instrument revokes the previous instrument WAMA—2021-204595 and is in force until 1 August 2025 unless revoked sooner.

MA402**WESTERN AUSTRALIAN MARINE ACT 1982****EXEMPTION OF ELECTRIC HYDROFOILS FROM COMPLIANCE WITH CERTAIN PROVISIONS OF THE NAVIGABLE WATERS REGULATIONS 1958**

(WAMA—2023—206266)

I, Mark Briant, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982*, hereby exempt electric hydrofoils from compliance with the following regulations of the *Navigable Waters Regulations 1958*—

- a. Regulation 52A which requires vessels to be equipped with lifejackets.
- b. Regulation 458(7)(a)(i), (ii) and (iii) which require vessels to display registration numbers of a certain size, in a specified location.

The exemptions above are subject to the following conditions—

Registration—

1. The electric hydrofoil shall display the registration number allotted to it on the left and right sides of the board, each digit of the number shall be black and shall be not less than 50 mm in height and 12 mm in width; and where the background of each digit is not white, each digit of the number shall have a white surround not less than 7 mm in width; and each digit of the number shall be of plain block design and not script and be vertical and not slanting.

Operation—

2. The electric hydrofoil is operated only between the hours of sunrise and sunset.

Safety Equipment—

3. An operator of an electric hydrofoil outside protected waters and more than 400m from any shore, is to—
 - (a) wear any of the following, appropriate in terms of buoyancy and size to the body mass of that person—
 - i. Level 50 lifejacket;
 - ii. Level 50S lifejacket
 - iii. Level 100 lifejacket;
 - iv. Level 150 lifejacket;
 - v. Level 275 lifejacket;
 - vi. SOLAS lifejacket;
 - vii. PFD Type 1;
 - viii. PFD Type 2;
 - ix. PFD Type 3; and
4. The required safety equipment is maintained in a serviceable condition and produced to a DoT officer upon request.

This instrument does not exempt an electric hydrofoil from being operated in compliance with other marine legislation requirements including speed restrictions, recreational skipper's ticket requirements and the *Prevention of Collisions at Sea Regulations 1983*.

The terms in this instrument have the same meaning as in the Act and the Regulations.

This instrument revokes instrument WAMA—2023—206139 and remains in force until 1st of August 2025, unless revoked sooner.

WESTERN AUSTRALIAN MARINE ACT 1982

EXEMPTION FOR JET KARTS FROM COMPLIANCE WITH VARIOUS PROVISIONS OF THE *NAVIGABLE WATERS REGULATIONS 1958*

(WAMA—2023—206109)

I, Mark Briant, acting Director Waterways Safety Management, Department of Transport, and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982*, exempt jet karts from compliance with—

- regulations 51D, 52, 52A, and 52C of the *Navigable Waters Regulations 1958* (the *Regulations*); and
- subregulation 528(1) of the *Regulations* when operating within 400m of any shore.

This exemption is subject to the following conditions—

1. the driver of a jet kart wears an appropriate lifejacket, as defined in regulation 50B of the *Regulations*; and
2. the jet kart carries a means of bailing out water.

The term 'jet kart' means a personal watercraft, modified temporarily or permanently so as to be operated by a person within it rather than on it.

This instrument revokes WAMA—2022—204993 and is valid until 1 August 2025 unless revoked sooner.

WESTERN AUSTRALIAN MARINE ACT 1982**EXEMPTION FOR TOW-IN SURFING ACTIVITIES FROM REGULATIONS 48A(2) AND 49 OF THE
NAVIGABLE WATERS REGULATIONS 1958**

(WAMA—2023—206268)

I, Mark Briant, A/Director Waterways Safety Management, Department of Transport, a delegate of the Chief Executive Officer, acting pursuant to section 115A of the *Western Australian Marine Act 1982*, hereby exempt a person from the application of the following regulations while they are operating a personal watercraft (PWC) to carry out tow-in surfing activities—

- (a) Regulation 48A(2) of the *Navigable Water Regulations 1958* (by which the towing of water skiers may only occur in gazetted water-skiing areas); and
- (b) Regulation 49 of the *Navigable Water Regulations 1958* (by which the driver of a speed boat towing a water skier must be accompanied by another person to keep watch over the skier).

This exemption is subject to the following conditions—

The person

1. The person is 17 years of age or over;
2. The person wears a kill switch lanyard on the wrist or attached to their personal floatation device; and
3. The person gives way to all other aquatic activities (for example; swimmers, paddle surfers, other vessels, persons on the shore).

The PWC

4. The PWC is equipped with—
 - a. A rescue sled—
 - (i) of a minimum size of 90cm width, 1.2m length and 7cm thickness equipped with a minimum of five (5) grip handles;
 - (ii) the load on which does not exceed the load capacity recommended by the manufacturer;
 - b. An additional kill switch lanyard, which is wrapped around the handlebars;
 - c. A marine transceiver as defined in the *Navigable Waters Regulations 1958*;
 - d. An effective quick release floating tow rope;
 - e. An effective bow tow line;
 - f. A mask and a safety knife, each effective and each in a readily accessible location; and
 - g. A suitable first aid kit.

The person towed

5. Only one person is towed at a time; and
6. The person being towed holds a Recreational Skippers Ticket

The craft towed

7. Only one craft is towed at a time; and
8. The towed craft is not motorised.

The activities

9. The tow-in surfing is not in protected waters, any gazetted water ski, PWC restricted or prohibited areas;
10. The tow-in surfing activities do not impede the safe passage or navigation of any other craft;
11. The tow-in surfing activities are a minimum of 50 metres from any other tow-in surfing activity and 200 metres from all other aquatic activities (for example, swimmers, paddle surfers, other vessels, persons on the shore); and
12. The tow-in surfing activities take place between sunrise and sunset.

This exemption does not exempt any person or vessel from the application of any other legislation including speed restrictions and the *Prevention of Collisions at Sea Regulations 1983*.

This instrument remains in force until 1 August 2025 inclusive unless revoked sooner.

WESTERN AUSTRALIAN MARINE ACT 1982
NAVIGABLE WATERS REGULATIONS 1958
(WAMA-2023-206138)

Approval for Australian Power Boat Association members and exemption from compliance with certain regulations of the Navigable Waters Regulations 1958 when participating in power boat races at the Western Australian Powered Water Sports Area and gazetted racing area at Lake Towerrinning.

I, Peter Beattie, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to power in section 115A of the *Western Australian Marine Act 1982* (the Act) **hereby exempt** bona fide Australian Power Boat Association (APBA) vessels participating in organised races in—

- the Western Australian Powered Water Sports Area, made under regulation 48A of the *Navigable Waters Regulations 1958* (the Regulations) and published in the *Government Gazette* on 27 February 2015; and
- the Water Ski and Motorboat Racing Area at Lake Towerrinning, made under regulation 48A of the Regulations and published in the *Government Gazette* on 25 September 2018;

from compliance with regulations 48(c) and 48(d)(iv) of the Regulations.

In accordance with regulation 48(a) of the Regulations, I also **hereby grant approval** for the vessels to exceed the speed limit in regulation 48(a)(i) in the same circumstances.

In addition, pursuant to regulation 47F of the Regulations, I **hereby exempt** bona fide APBA members under the age of 17 participating in organised races from compliance with regulations 47A(3), 47A(4) and 47A(5) of the Regulations.

This exemption and approval are subject to the following conditions—

1. All of the conditions in DoT's event approval letter issued under regulation 51C of the Regulations are adhered to;
2. The event commences after sunrise and is completed before sunset;
3. APBA ensures a sufficient number of suitable rescue craft are available throughout the duration of the event;
4. APBA ensures that a suitable medical response, including evacuation and communication plans, is in place throughout the duration of the event;
5. All aspects of Western Australian Speed Boat Club's Safety Management Plans and the APBA Rule Book are adhered to; and
6. APBA officials carry a copy of this exemption during races or produce it to DoT as soon as possible on request.
7. The organiser conducts a sweep of the event area prior to the event to ensure there are no risks to the participants or members of the public.
8. All participants must be accounted for at the end of each event.

This instrument is to be known as WAMA-2023-206138 and is valid from the date it is signed until 1 August 2025 inclusive unless revoked sooner.

WESTERN AUSTRALIAN MARINE ACT 1982
NAVIGABLE WATERS REGULATIONS 1958

APPROVAL AND EXEMPTION FROM CERTAIN SPEED AND EQUIPMENT PROVISIONS FOR VESSELS
AND CRAFT PARTICIPATING IN SURF LIFE SAVING WESTERN AUSTRALIA EVENTS AND
ASSOCIATED ORGANISED TRAINING.

(WAMA—2023—206360)

I, Peter Beattie, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982* (the Act), and regulation 52CA of the *Navigable Waters Regulations 1958* (the Regulations), hereby make the exemptions, approval, and set the conditions below in relation to—

- (a) inflatable rescue boats and personal watercraft ("SLSWA vessels"); and
- (b) paddle boards, surf skis and surf rowboats ("SLSWA craft")

under the control of a bona fide member or employee of Surf Life Saving Western Australia ("SLSWA") whilst participating in—

- (c) a SLSWA aquatic event listed in the SLSWA Activity Register; or
- (d) the organised training for such an event.

Exemptions

1.SLSWA craft are exempt from compliance with regulations 52BAD(4) and 52BAD(5) while taking part in any race or regatta for which permission has been granted by the chief executive officer under regulation 51C and the race or regatta is listed in the SLSWA Surf Sports Event Calendar (this exemption does not include training for a race or regatta), pursuant to regulation 52CA of the Regulations.

2.SLSWA vessels are exempt from compliance, pursuant section 115A of the Act: in relation to—

- (a) regulations 48(b), (c), (d) and (e), 49, 52A, 52B, 52BAA and 52BAB of the Regulations

subject to the conditions set out below;

- (b) closure of navigable waters notices made under section 66 of the Act and published in the *Government Gazette* while conducting bona fide vessel launch and recovery activities or participating in an aquatic event; and
- (c) notices limiting the speed of vessels made under section 67 of the Act and published in the *Government Gazette* while participating in an aquatic event.

Approval

12. Arrangements are made to account for participants upon completion of the events; and
13. All aspects of the SLSWA Safety Equipment and Exemption Explanation Instrument 2023 are adhered to.


