### LOCAL GOVERNMENT ACT 1995

*City of Bayswater*

#### HEALTH AMENDMENT LOCAL LAW 2024

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Bayswater resolved on 26 March 2024 to make the following amendment local law.

#### Part 1—Preliminary

##### 1. Citation

This local law may be cited as the *City of Bayswater Health Amendment Local Law 2024*.

##### 2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

##### 3. Principal Local Law

This local law amends the *City of Bayswater Health Local Law 2023* published in the *Government Gazette* on 25 August 2023.

#### Part 2—Amendments

##### 4. Clause 1.3 amended

In Clause 1.3 the definition of **approved** is moved on a separate line.

##### 5. Clause 3.1 amended

Clause 3.1 is amended as follows—

- (1) delete paragraph (m);
- (2) retitle paragraph (n) to (m); and
- (3) replace subclause (l) with the following—
  - (l) “maintain all pipes, fittings and fixtures connected with water supply, drainage or sewage so that they comply in all respects with the provisions of the Metropolitan Water Supply, Sewage and Drainage By-Laws, National Plumbing Code, Treatment of Sewage and Disposal of Effluent and Liquid Waste Regulations and any other legal requirements to which they are subject; and”

##### 6. Clause 4.3 amended

In Clause 4.3—

- (1) the definition of “receptacle” is moved on a separate line; and
- (2) the definition of “waste” is moved on a separate line.

##### 7. Clause 4.4(2)(a) amended

In Clause 4.4(2)(a) reference to subsection 4.9(1) is amended to subsection “4.10(2)”.

**8. Clause 5.19(1)(b) amended**

In Clause 5.19(1)(b) full stop after “cage birds” is deleted.

**9. Clause 5.19(1)(c) amended**

In Clause 5.19(1)(c) full stop after “peahen” is deleted.

**10. Clause 5.19(1)(d) amended**

In Clause 5.19(1)(d) the word May is replaced with “may”.

**11. Clause 6.5(3) amended**

Clause 6.5(3) is deleted.

**12. Clause 6.7 amended**

In Clause 6.7 subclause (b) amended to be contained on one line.

**13. Clause 6.16(1) amended**

In Clause 6.16(1)—

- (1) delete the words “shall at all times take effective measures to eradicate any rodents in or on the premises”
- (2) delete Clause 6.16(1)(a) and replace with the following—
  - “(a) at all times, take effective measures to eradicate any rodents in or on the premises and keep the premises free from rodents, including—
    - (i) protecting food stuffs;
    - (ii) using a rodenticide bait or a properly baited trap;
    - (iii) minimising rodent access to water on the premises; and
    - (iv) removing accumulated refuse or potential rodent food sources; and”

**14. Clause 7.3(4) amended**

Clause 7.3(4) is deleted.

**15. Clause 7.10(3) amended**

Clause 7.10(3) is deleted.

**16. Clause 8.1 amended**

In Clause 8.1 the definition of “lodging house” is amended to be contained in a separate definition on a new line.

**17. Clause 8.7(1) amended**

Clause 8.7(1) is deleted, and sub clauses renumbered.

**18. Part 11: Objections and Appeals**

Following Part 10—Offences, Penalties, Fees and Expenses insert the following—

**“PART 11—OBJECTIONS AND APPEALS****11.1 Objection and appeal rights**

When the local government makes a decision—

- (a) under clause 10.1 or
- (b) as to whether it will renew, or cancel a permit,

the provisions of Division 1 of Part 9 of the *Local Government Act 1995* and regulation 33 of the Regulations apply to that decision.”

## METROPOLITAN REGION SCHEME AMENDMENT 1418 (BASIC)

Part Lot 700 Pinjar Road, Sinagra  
Notice of Approved Amendment

File: RLS/1118

The Minister for Planning has approved, as advertised, the abovementioned amendment to the Metropolitan Region Scheme (MRS). The amendment is shown on Western Australian Planning Commission (WAPC) plan number 3.2824 and is effective from the date of publication of this notice in the *Government Gazette*.

The purpose of the amendment is to transfer approximately 475 square metres of land in Lot 700 Pinjar Road, Sinagra from the Other Regional Roads reservation to the Urban zone under the MRS.

The amendment will rationalise the extent of the Other Regional Roads reservation for this part of Pinjar Road and will facilitate the development of the land in the amendment area for residential purposes.

Pursuant to section 126(3) of the *Planning and Development Act 2005*, the WAPC has the option of concurrently rezoning land that is being zoned urban under the MRS, to a Development zone (or similar) in the corresponding Local Planning Scheme.

The WAPC agreed to the land being zoned Urban in MRS Amendment 1418 being transferred to the Urban Development zone in the City of Wanneroo District Planning Scheme No. 2. This amendment to District Planning Scheme No. 2 is effective from the date of publication of this notice in the *Government Gazette*.
