A coin-freed sale apparatus characterised by the combination of a spiral spring adapted to receive in its convolutions the goods to be delivered with a horizontal or substantially horizontal channel or casing, the inner section of which corresponds to the size of the articles to be delivered, so as to prevent the said articles rotating with the said spring, and with a device adapted to allow said spring to be axially rotated and with a stop mechanism, determining the number of rotations which the said device may impart to the spring after the introduction of a predetermined coin into the apparatus, substantially as hereinbefore described and illustrated by the accompanying drawings. ings.

2. In coin-freed sale apparatus the combination of a spiral spring a with a channel b the section of which corresponds to the size of the goods to be delivered substantially as hereinbefore described and illustrated by the accompanying drawings.

In coin-freed sale apparatus the combination of a cam h fixed on the shaft d with a pawl i adapted to prevent the rotation of the said cam h in one direction and of a pawl k adapted to prevent rotation in the opposite direction substantially as described and illustrated by accompanying drawings.
