HEREAS under and in pursuance of "The VV Small Debts Ordinance, 1863," by Proclamation dated the 18th day of October, 1899, the then Governor appointed the third Tuesday in each and every month as the day for holding the Local Court at Laverton, in the Mount Margaret Magisterial District: And whereas it is expedient to alter the time for holding the said Court, in the said District, for the month of February next: Now THEREFORE I, the Honourable Sir Arthur Lawley, K.C.M.G., Governor of the State of Western Australia, with the advice of the Executive Council, in pursuance of the powers in me vested in that behalf by the said Ordinance, do hereby appoint the second Wednesday in February next for holding the said Court, in the said District, in lieu of the third Tuesday aforesaid.

No. 47), the Governor is empowered by Proclamation in the Government Gazette:-

- 1. To declare any West Australian waters to be close waters for all or any kind of fishing.
- To regulate the length and meshes of nets.

Now THEREFORE I, the Honourable Sir Arthur Lawley, K.C.M.G., Governor as aforesaid, in pursuance of the power and authority vested in me by the said recited Act, and by and with the advice and consent of the Executive Council, do hereby declare that it shall be unlawful for any person to fish by means of any net or fixed engi e within the waters of the Preston, Collie, or Brunswick rivers, and that portion of the Leschenault Estuary lying South of a straight line drawn from a point 50 chains Southerly from the North-West corner of Wellington Location No. 31, to the South-East corner of Wellington Location No. 24, on the opposite or Western bank of the said estuary; and to use any net, the length of which shall exceed 150 yards (two or more nets not to be coupled), the mesh of which nets shall not be less than 3in from knot to knot when stretched out, in the waters of the Leschenault Estuary North of the said straight line.

Every person committing a breach of this Regulation shall be liable, on conviction, to a penalty of not more than £20, and shall forfeit the implements used and all fish which shall have been taken.
