WESTERN AUSTRALIA, TO WIT. SPRED. G. D. BEDFORD, Governor.

By His Excellency Admiral Sir Frederick George Denham Bedford, Knight Grand Cross of the Most Honourable Order of the Bath, Governor in and over the State of Western Australia and its Dependencies, etc., etc., etc.

WHEREAS by "The Land Act Amendment Act, 1904," it is provided that any Proclamation declaring any Crown Lands a State Forest may be rescinded, amended, or annulled in part or in whole: Now therefore I, the said Governor, acting with the advice of the Executive Council, and in exercise of the power in this behalf conferred by the said Act, do dereby amend the Widgemooltha State Forest by excising the area described in the Schedule hereunder:—

### Schedule.

A strip of land, 12 miles wide, with the Coolgardie-Widgemooltha Railway in its centre, extending South-Eastward from the 25th Mile Post to the 40th Mile Post thereon. Plans 18 and 25/300.
