FORFEITURE OF LEASES AND LICENSES.

Department of Lands and Surveys, Perth, 1st June, 1910.

THE undermentioned Leases and Licenses have been forfeited through non-payment of rent, etc., for the first half of the year 1910. Under the power reserved to the Hon. the Minister, the whole of the Leases and Licenses have been withdrawn from sale, but the land comprised therein, save such areas as it may in the meantime be decided to reserve, will be made available for re-selection on and after 1st July, 1910, under the conditions prescribed in the Land Laws and Regulations now in force.

All applications for land in the South-Western Division must be lodged at the offices of the Land Agents for the district in which the land is situate.

All improvements existing on any lots are the property of the Crown, and shall be paid for by the Selector as the Hon. the Minister for Lands may direct.
