I, David Ernest Williams, being the Medical Officer of the Prison at Fremantle, do hereby certify that I have this day witnessed the execution of David Horatio Smithson, lately (as I am informed) convicted and duly sentenced to death at the Supreme Court, and I further certify that the said David Horatio Smithson was, in pursuance of such sentence, hanged by the neck until he was dead.

Given under my hand this 25th day of July, in the year 1911.

We, the undersigned, do hereby declare and testify that we were this day present when the extreme penalty of the law was executed on David Horatio Smithson, lately (as we are informed) convicted at the Supreme Court and duly sentenced to death on the 6th day of July, 1911, and that the said David Horatio Smithson was, in pursuance, of such sentence, hanged by the neck until he was dead.
