WHEREAS, under the provisions of "The Early Closing Act, 1902," a majority of shopkeepers of shops (not being shops mentioned in Schedule One) situate within any district may present to the Minister a memorial under their hands, asking that the days appointed for closing at 1 o'clock and 10 o'clock respectively may be altered to the days specified in the memorial; whereupon the days in each week for the closing of shops in such district at 1 o'clock and 10 o'clock respectively may be altered accordingly by Proclamation: And whereas a memorial has been so presented under the hands of the majority of the shopkeepers of such shops in the District of Northampton asking that the day for the closing of shops in the said District at 1 o'clock be altered from Wednesday to Thursday in each week: And whereas it is desirable to accede to the prayer of such memorial: Now therefore I, the said Governor, do, with the advice of the Executive Council, hereby alter the day appointed for the closing of such shops in the District of Northampton at 1 o'clock from Wednesday to Thursday in each week accordingly.

NOTICE is hereby given that a petition dated the 5th day of September, 1911, has been presented to His Excellency the Governor, the substance and prayer

whereof is that the District of the Municipality of Queen's Park may be divided into Wards, as follows:—

East Ward.—Bounded by lines starting at a point on the Southern Bank of the Canning River, opposite the intersection of Wharf Street and Chapman Road; thence North-Easterly along the centre of Wharf Street to the Northern boundary of the Municipality; thence Easterly along the Northern boundary and along the Eastern and Southern boundaries of the Municipality to the starting point.

Central Ward.—Bounded by lines starting at a point on the Southern bank of the Canning River opposite the intersection of Wharf Street and Chapman Road; thence South-Westerly along the Southern boundary of the Municipality to a point opposite the centre of Watts Street; thence North-Easterly across the river and along the centre of Watts Street and the Southern and Eastern boundaries of Lot 31 to the centre of Chapman Road; thence along the centre of Chapman Road to a point opposite the centre of Burton Street; thence along the centre of Burton Street and the Perth-Albany Road to the centre of Mills Street; thence along the centre of Mills Street and the North-West boundary of Lot 337 to the Northern boundary of the Municipality; thence along the said boundary to the centre of Wharf Street; thence South-Westerly along the centre of Wharf Street to the starting point.

West Ward.—Bounded by lines starting at a point on the Southern bank of the Canning River opposite the centre of Watts Street; thence along the Southern, Western, and Northern boundaries of the Municipality to the North-West boundary of Lot 337; thence South-Westerly along the boundary of the said lot and the centre of Mills Street to the Perth-Albany Road; thence along the centre of the said road and Burton Street to the centre of Chapman Road; thence along the centre of Chapman Road to the Eastern boundary of Lot 31; thence along the Eastern and Southern boundaries of Lot 31 and the centre of Watts Street to the starting point.

The petition is signed by one-third of the persons on the Municipal Roll.
