That portion of Conditional Purchase Lease 9392/56 (Victoria Location 5470), containing 22 acres 2 roods (ex road), bounded on the South-Eastward and South-Westward by lines starting from a point situate 324deg. 47min. 56 chains 95 links and 234deg. 47min. 7 chains 50 links from the intersection of the South-Western side of a two chain surveyed road passing diagonally through said location with its Southern boundary, and extending respectively 54deg. 47min. 17 chains and 324deg. 47min. 15 chains; the opposite boundaries being parallel and equal. (Excluding that portion of a two chain road situate within these boundaries.) (Plan 122/80.)

#### PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir Gerald StrickTO WIT. Sland, Count della Catena, Knight
Commander of the Most Distinguished
Order of St. Michael and St. George,
Governor in and over the State of
Western Australia and its Dependencies, etc., etc.

WHEREAS by "The Insect Pests Amendment Act, 1898," it is provided that the Governor may from time to time by Proclamation prohibit, either absolutely or except in accordance with Regulations under the Act, the bringing into any specified portion of Western Australia, from any other portion or specified portion of Western Australia, of any specified plant, fruit, fungus, parasite, insect, or other thing which, in his opinion, is diseased or likely to spread disease: And whereas, in the opinion of the Governor, the bringing into the South-West Division (as defined by "The Lands Act, 1898") of the State of Western Australia of stable manure or other manure containing vegetable matter from any other other manure containing vegetable matter from any other portion of the State is likely to spread the disease known as Irish Blight in the South-West Division of the State: Now therefore I, the said Governor, with the advice and consent of the Executive Council, do hereby prohibit absolutely the bringing into the South-West Division of the State of Western Australia, from any other portion of the said State, of stable manure or other manure containing vegetable matter.

This Proclamation shall have operation and effect on and from the date of publication in the Government Gazette.
