

(2.) The Chairman and not less than two other members of the Board shall severally sign such certificate.

12. Any resident owner whose name appears on the special roll and—

- (a.) who intends to be absent from the District on the day of the election; or  
 (b.) resides more than five miles from a polling place; or  
 (c.) is prevented by illness or infirmity from attending a polling place,

may at any time before the day appointed for the holding of the poll apply personally or in writing to the returning officer for a postal voting paper. The returning officer shall thereupon supply the same and shall make a mark against the name of the said owner on the said roll.

12A. Voting papers shall be as prescribed by Form No. 41, and postal voting papers shall be as prescribed by Form No. 42.

13. Any person who has applied for and received a postal voting paper for the purpose of voting shall not be entitled to vote otherwise.
