# ROAD DISTRICTS.

Descriptions of Boundaries of Road Districts.

#### THE ROADS ACT, 1911.

Department of Works and Trading Concerns, Perth, 21st June, 1918.

HIS Excellency the Governor in Executive Council has been pleased to approve of the publication of the description of the boundaries of the Road Districts throughout the State as set out in the Schedule.

#### ALBANY ROAD DISTRICT.

Bounded on the Northward and North-Westward by lines commencing at the intersection of a line connecting the South-West corner of Hay Location 72, with Survey Mark FTV, with the production West of the North boundaries of Locations 677 and 371, and extending Eastward along the said production and North boundaries, part of the West and the North boundary of Plantagenet Location 1899, a West, a South, a West, a South, and part of an East boundary of Location 1210, the North and part of the East boundary of Location 3669, the North boundary of Location 2694, part of the West and the North boundary of Location 765, part of the North boundary of Location 2473, a West, the North, and the East boundary of Location 3513, part of the North boundary of Location 521, part of the West and the North boundary of Location 753, the North boundary of Location 754, and to and along the South boundaries of Locations 3531 and 2671, part of the West, the North, and part of the East boundary of Location 2783, to the production West of the North boundary of Location 3247, and along said production and North boundary and part of the East boundary of said Location 2347 to the production West of the North boundary of Location 3514 to its South-Bast corner; thence along the production East of the South boundary of Location 216, part of the North and the East boundary of Location 3514 to its South-Bast corner; thence along the production East of the South boundary of Location 3514 to the production South of the East boundary of Location 1985; thence along the latter production and the said East boundary of Plantagenet Location 228, and along part of said South boundary of said Location 409, and along part of the East and a North boundary of Location 1140, the East and a North boundary of Location 1140, the East and a North boundary of said Location 410, and along said West boundary of said Location 410, and along said West boundary of said Location 1248, the East and a North boundary of said Location 1240, the East and a North West corner of Plantagenet Location 2249, and along its West boundary, part of the South, the West, and the North boundary of Location 1610 to the right bank of the Kalgan River, and along said bank to the production West of the South boundary of Location 74, along said production and South boundary and part of its East boundary, the West boundaries of Locations 1112 and 1113, and part of the latter's North boundary, the West and the North boundary of Location 1114, part of the West boundary of Location 114, part of the West boundary of Location 1645, to its North-West corner; thence North-Eastward to the North-West corner of Lease 324/41A and along its North boundary to its North-East corner; thence North-Eastward to the South-East corner of Reserve 1090, and along its East boundary to its North-East corner; thence again North-Eastward to the intersection of a line passing through Peak Barnett, Warrungup Hill, and Ellen Peak, and the production South of the West boundary of Kent Location 713; thence North-Eastward to Survey Post L28 on the Pallinup River; thence to the South-West corner of Pastoral Lease 2419/93 and along its West and North boundaries; thence again North-Eastward through Survey Posts L10 and L11 and continuing to the South-West corner of Location 647 along part of its South boundary, a West, a South, and the East boundary of Pastoral Lease 2330/93 to its North-East corner; thence North-Eastward to the 222 Mile Post on the Rabbitproof Fence, and onwards to the South-West corner of Location 613, and along a West boundary of same, part of the South, the West, and the North boundaries of Location 629, again a West and the North boundary of Location 613; thence North-Eastward to Survey Mark P18.

Bounded on the East by a line from said Survey Mark P18 to the North-West corner of Reserve 512A and along its West boundary and its production South to the sea coast.

to the sea coast. Bounded on the South-Eastward and Southward by the shores of the Indian Ocean to the South-West corner of Reserve 2002.

On the Westward by lines commencing at the aforesaid South-West corner and extending along the Southern and Eastern shores of Wilson Inlet to the right bank of the Hay River and along said bank to opposite Survey Mark FIV; thence Northward in the direction of the South-West corner of Hay Location 72 to the starting point. Inclusive of all islands adjacent to the sea coast and exclusive of Albany Municipality.

#### ARMADALE-KELMSCOTT ROAD DISTRICT.

Bounded on the Northward by lines commencing at the North-West corner of Canning Location 64, and extending along its North boundary, the North boundaries of Locations 633 and 342 and part of the latter's East boundary, the North, and parts of the East boun-
