Alteration of the External Boundaries of the Kalgoorlie Road District and the Kalgoorlie Municipality.

IT is hereby notified, for general information, that by virtue of the powers conferred by Section 8 of "The Roads Act, 1911," and Section 26 of "The Municipal Corporations Act, 1906," it is the intention of the Governor, by Order in Council, to alter the boundaries between the Kalgoorlie Road District and the Kalgoorlie Municipal District, by making the common boundary the centre of so much of Bourke Street as

lies between Oxford and Russel Streets, in lieu of the North side of Bourke Street as at present, and to alter the external boundaries of the Kalgoorlie Road District and the Kalgoorlie Municipal District accordingly.
