PERTH ROAD BOARD.

No. 9 Loan.

NOTICE is hereby given that at a meeting of the Perth Road Board held on the 29th day of April, 1919, it was resolved to raise a Loan of Three thousand five hundred pounds (£3,500), of which sum Two thousand five hundred pounds (£2,500) to be expended in the Osborne Ward, in the construction of works and undertakings; rate of interest not to exceed six per cent. per annum; to be a charge on the whole Ward. A thousand pounds (£1,000) to be expended in the Coast Ward, in the construction of works and undertakings, rate of interest not to exceed six per cent. per annum; to be a charge on the whole of the Ward.

The plans, specifications, and estimates of such works and undertakings, and the statement showing the proposed expenditure of the money, are open for inspection at the Office of the Perth Road Board, No. 3 Basement, A.M.P. Buildings, St. George's Terrace, Perth, for one month from date of the publication hereof, between the hours of 10 o'clock in the forenoon and 4 o'clock in the afternoon on any day except Saturdays and Sundays.

The amount of £3,500 is proposed to be raised by sale of debentures, rate of interest not to exceed six per centum per annum, with a sinking fund of two pounds per cent. per annum, for a term of thirty years; the debentures to be payable at the Office of the Perth Road Board thirty years after date of issue.
