THE HEALTH ACT, 1911-1918.

I, REGINALD CYRIL EVERITT ATKINSON, Commissioner of Public Health, do hereby, by virtue of the powers conferred upon me under the provisions of "The Health Act, 1911-1918," order that the area described within the undermentioned boundaries be quarantined:—

Bounded on the North by an East and West line passing through a point five chains to the North of the Upper Swan Siding on the Midland Railway Line; on the East by a North and South line passing along the Eastern boundary of the Lion Mill Townsites; on the South by an East and West line passing through the 20-mile post (South of Armadale) on the Perth-Bunbury Railway, and on the West by the sea-coast.

And I do hereby forbid all persons to leave the area described within the said boundaries until they have been medically examined and found to be free from any dangerous infectious disease, and hold a certificate in the form set out hereunder:—

DEPARTMENT OF PUBLIC HEALTH.

Permit to Travel outside a prescribed Quarantine Area.

I,...., hereby declare that I have not, to the best of my knowledge and belief, been in contact with any person suffering from influenza during the past seven days.
