ORDER IN COUNCIL.

At the Executive Council Chamber, at Perth, this
7th day of January, 1920.

WHEREAS by "The Prices Regulation Act, 1919," it is provided that the term "foodstuffs" means goods declared by the Governor, by notice in the *Gazette*, to be "foodstuffs" for the purposes of the said Act, and "necessary commodities" means goods declared by the Governor, by notice in the *Gazette*, to be "necessary commodities" for the purposes of the said Act: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby declare that the goods mentioned in Part I. of the Schedule hereto shall be "foodstuffs" for the purposes of the said Act, and that the goods mentioned in Part II. of the said Schedule shall be "necessary commodities" for the purposes of the said Act.
