IT is hereby notified, for public information, that His Excellency the Governor in Executive Council has been pleased to approve of the following Order in Council fixing the maximum wholesale price of Chaff.

The Prices Regulation Act, 1919.

Determination of Prices.

ORDER IN COUNCIL.

WHEREAS under the provisions of "The Prices Regulation Act, 1919," and as amended by "The Prices Regulation Act Amendment and Continuance Act, 1920," the Governor may, on the recommendation of the Commissioners, by Order in Council determine the maximum prices, whether wholesale or retail, which may be charged for foodstuffs and necessary commodities in any proclaimed area; and without affecting the generality of the powers conferred may determine such prices on the basis of landing, manufacturing, landed deliyery, or other cost, and may declare what items may or may not be included in such cost: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council and on the recommendation of the Commissioners, doth hereby determine that the price of the necessary commodity mentioned in the First Schedule hereto shall be the maximum wholesale price that may be charged for such necessary commodity within the Metropolitan Area, and, subject as provided in paragraph 2 of the First Schedule, in the other proclaimed areas set out in the Second Schedule.

First Schedule.

The maximum wholesale price at which chaff may be sold or supplied shall be as follows:—

- 1. Within the Metropolitan Area, at the rate of £10 a ton on rails, or ex store.
- 2. Within the areas set out in the Second Schedule hereunder, the wholesale price of Chaff shall not exceed the maximum wholesale price fixed within the Metropolitan Area less the actual charge for transport by rail from any of the said areas to the Metropolitan Area.

Second Schedule.

Chidlow's Well. Beverley. Gnowangerup. Narrogin. Northam. Goomalling. Wagin. Katanning. York. Meckering. Kellerberrin. Tammin. Bruce Rock. Wongan Hills. Cunderdin. Wyalcatchem.

This Order in Council shall take effect as from the 22nd day of June, 1921.

OFFAL.

IT is hereby notified, for public information, that His Excellency the Governor in Executive Council has been pleased to revoke the Order in Council dated the 8th day of June, 1921, proclaiming the maximum wholesale and retail prices of Offal.
