WHEAT MARKETING ACT, 1921.

Determination of Prices for Bread and Products of Wheat for Local Consumption.

ORDER IN COUNCIL.

WHEREAS under the provisions of "The Wheat Marketing Act, 1921," the Governor may determine the maximum prices that may be lawfully charged for bread and the products of wheat for sales for local consumption in the State: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, doth hereby determine that the prices for bread and the products of wheat for sales for local consumption in the State shall, as from midnight on 2nd day of May, 1922, and until further order, be the prices mentioned in the schedule hereto as the maximum prices that may be lawfully charged for the same in the areas mentioned.

Schedule.

BREAD.

- (a.) Bread, 5d. per 21b. loaf, delivered, cash or booked.
- The above-mentioned retail prices have been fixed with due regard to the cost of transport within the following areas, namely:

Metropolitan, Geraldton, Kellerberrin, Northam, York, Brookton, Pingelly, Narrogiu, Wagin, Katanning, and Bunbury.

Within all other proclaimed areas, the equivalent of any additional cost actually incurred in transportation of flour or bread beyond the said areas specified may be added to the above-mentioned prices.

FLOUR.

- 3. The maximum prices at which flour may be sold or supplied, and which said prices shall include the containers in which the said flour is sold or supplied, shall be as follows:-
- 4. Within the Metropolitan, Bunbury, and Geraldton Areas,-
- (a) Wholesale—delivery at mill door or on rail at mill siding-
 - In sacks of 150 lbs.—£13 7s. 6d. per ton of 2,000 lbs. In bags of 50 lbs.—£14 15s. per ton of 2,000 lbs. In bags of 25 lbs.—£15 17s. 6d. per ton of 2,000 lbs.
 - (5s. per ton may be added to these prices when booked for more than seven days.)

 - (b) Wholesale, except as above—
 In sacks of 150 lbs.—at the rate of £13 19s. 3d.
 per ton of 2,000 lbs., or £1 1s. 3d. per sack.
 In bags of 50 lbs.—at the rate of £15 8s. 3d. per

 - ton of 2,000 lbs., or 7s. 10d. per bag.
 In bags of 25 lbs.—at the rate of £16 12s. 6d.
 per ton of 2,000 lbs., or 4s. 2d. per bag.
 - (e) Retail-

- In sacks of 150 lbs.—£1 4s. 3d.

- In bags of 50 lbs.—9s. 1d.
 In bags of 25 lbs.—4s. 9d.
 Loose, per dozen pounds, 2s. 6d. Less than one dozen pounds, at the rate of 2½d. per lb.
 - (If booked for more than seven days, the following charges may be added:-

 - 10d. per sack of 150 lbs. 5d. per bag of 50 lbs. 3d. per bag of 25 lbs.)
- 5. Within the Kellerberrin, Northam, York, Brookton, Pingelly, Narrogin, Wagin, and Katanning areas:—
 (a) Wholesale—delivery at mill door or on rail at mill siding-

 - In sacks of 150 lbs.—£13 per ton of 2,000 lbs.
 In bags of 50 lbs.—£14 7s. 6d. per ton of 2,000 lbs.
 In bags of 25 lbs.—£15 10s. per ton of 2,000 lbs.
 - (5s. per ton may be added to these prices when booked for more than seven days.)
