AT a meeting of the Executive Council held in the Executive Council Chamber, Perth, this 4th day of December, 1923, the following Order in Council was authorised to be issued:—

The Stock Diseases Act, 1895. ORDER IN COUNCIL.

WHEREAS by "The Stock Diseases Act, 1895," the Governor is empowered, by Order in Council to be published in the Government Gazette from time to time, to make, vary, alter, or revoke such Regulations under the said Act as may be deemed necessary for any of the purposes mentioned in the said Act: Now, therefore, His Excellency the Governor, in exercise of the powers vested in him as aforesaid, and acting by and with the advice and consent of the Executive Council, doth hereby make the following Regulations:—

- 1. All that portion of the State situated within a circle bounded by a circumference having a radius of thirty miles from the Town Hall, Fremantle (except the harbour of Fremantle as defined by or under "The Fremantle Harbour Trust Act, 1902"), is hereby established as a quarantine area under "The Stock Diseases Act, 1895," and is herein referred to as "the said area."
- 2. The said area shall include every holding any portion of which is within the said area.
- 3. For the purposes of these regulations the word "stock" includes cattle, sheep, goats, pigs, and dogs.
- 4. No person shall take or suffer or permit to be taken any stock which at any time are within the said area outside the said area, or allow any such stock to cross the boundary of the said area.

- 5. No person shall take or suffer or permit to be taken any stock from place to place within the said area without the permission in writing of the Chief Inspector of Stock, or suffer any stock to stray from place to place within the said area.
- 6. No person shall bring any stock or permit or suffer any stock to be brought into the said area without the consent in writing of the Chief Inspector of Stock.
- 7. No person shall take or send or suffer to be taken or sent from within the said area to any place without the said area any vegetables or fodder, or bags or similar things used for the carriage of fodder, whether the same shall have been brought into contact with any diseased stock or not, without the consent in writing of the Chief Inspector of Stock.
- 8. Any stock found straying at large within or from the said area, and any stock which shall be taken from or suffered or allowed to leave the said area without the permission in writing of the Chief Inspector of Stock, may be seized and destroyed.
- 9. The Chief Inspector of Stock may brand or cause to be branded, in such manner as he may think fit for identification, any stock within the said area, and no person shall hinder the Chief Inspector of Stock or any person acting with his authority in carrying out this regulation.
- 10. Any person committing a breach of any of the foregoing regulations shall be liable on conviction to a penalty not exceeding One hundred pounds.
