THE ROAD DISTRICTS ACT, 1919.

Greenbushes Road Board.

A By-law to provide for the Annual Registration and Keeping of Goats within the Townsite of Greenbushes.

THE Greenbushes Road Board, in pursuance of the powers vested in the said Board, under and by virtue of "The Road Districts Act, 1919," doth hereby make the following By-law, to have effect within the Townsite of Greenbushes:—

1. Annual Registration of Goats.

(a) All goats shall be registered annually with the Board at an annual registration fee of sixpence for each goat.

(b) Every registration shall be in force from the day of registration to the thirtieth day of June next following the date of registration.

(c) Every registration shall be effected within thirty days of the publishing of this By-law and thereafter within thirty days of the close of each financial year.

(d) Every registered goat shall have a collar round its neck, and the goat's registration disc shall be and remain attached to the collar.

(e) Every goat not having a registration disc attached to its collar, found within the Townsite of Greenbushes, may be seized and disposed of as the Board directs, and the owner shall be liable to a penalty of twenty shillings for every goat so found.
