PORT OF FREMANTLE.

Iron Buoy (Old Mine Case) adrift at Cockburn Sound.

Notice to Mariners.

THE Fremantle Harbour Trust Commissioners give notice to mariners and others navigating the waters of Cockburn Sound in the Outer Harbour of Fremantle that they have been advised by the Australian Naval Staff Office at Fremantle that a spherical iron buoy (an old mine case) was laid by H.M.A.S. "Marguerite" for instructional purposes in Lat. 32deg. 12min. South and Long. 115deg. 42½min. East, and was not recovered by that ship.

The buoy, which is painted red, has a height of 3ft. 9in. and a diameter of 3ft. 3in.; it is equipped with a sinker anchor and seven fathoms of mooring wire. It was sighted once at about Lat. 32deg. 12min. 30sec. South and Long. 115deg. 44min. 00sec. East, after which it is believed to have sunk or is slowly drifting towards the mainland, but may be a source of danger to navigation.
