AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 3rd day of June, 1938, the following Orders in Council were authorised to be issued:—

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 933/37.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act. 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of sections 20, 21, 22 and 23 of the said Act.

Description and Location of Reticulation Works Approved and Exempted—Metropolitan Reticulation Main Improvements, City of Perth:—Proposed 6-inch diameter water main commencing at the existing 6-inch diameter main at the intersection of Hay street and Pier street and proceeding thence in a south-easterly direction along Hay street to connect with the existing 8-inch diameter main at the intersection of Hay street and Victoria avenue (length about 18 chains).

The above main to be complete with valves, hydrauts and all necessary apparatus as shown in red on Plan M.W.S.S. & D.D., W.A., No. 6077.

This Order in Council shall take effect from the 3rd day of June, 1938.

ORDER IN COUNCIL.

Description and Location of Reticulation Works Approved and Exempted—Metropolitan Sewerage, Claremont District, Extension to Reticulation Area No. 4:—A 6-inch diameter pipe sewer commencing at Manhole No. 495B in Hammond street and proceeding south through Lots 34, 33 and 32 Bay road to Manhole 495C in the north-west corner of Lot 31 Bay road; thence west through Lot 28 George street to and across George street to Manhole 495D on the west side of George street in lieu of 6-inch diameter sewer commencing at Manhole 495B and south through Lots 34, 33 and 32 Bay road to new Manhole 495C in the south-west corner of Lot 32 Bay road, a distance of 156 feet; thence west through Lots 27, 26 and 25 Hammond street to and across George street to new Manhole 495D, a distance of 216 feet.

This Order in Council shall take effect from the 3rd day of June, 1938.
