Schedule.

(1) This by-law shall be read and construed with the by-laws made under the provisions of the Government Electric Works Act, 1914-1915, as amended and published in the Government Gazette on the 10th December, 1926; 20th May, 1927; 17th June, 1927; 27th November, 1931; 29th September, 1933; 2nd October, 1936; 31st December, 1937; and 8th July, 1938; and the by-laws made under the State Electricity Commission Act, 1945; and published in the Government Gazette on the 9th August, 1946; 11th October, 1946, and 11th July, 1947.

(2) Emergency—By-law Restricting the Use of Neon Signs.

In relation to the electricity supplied from the Commission's main generating station at East Perth by or through any Supply Authority, no person shall, until further notice, use or permit to be used, any such electricity for lighting purposes by any outside neon sign.

Any person committing a breach of this by-law shall be liable to a penalty not exceeding twenty pounds (£20).
