#### PRICES CONTROL ACT, 1948.

Prices Control Order No. 53.

Retail Price of Groceries-Northern Areas.

IN pursuance of the powers conferred upon me by the Prices Control Act, 1948, and the regulations for the time being in force thereunder, I, Constantin Paul Mathea, Prices Control Commissioner, under the said Act, hereby make the following Order:-

## Citation.

1. This Order may be cited as Prices Control Order No. 53.

## Revocation.

2. Price Control Order No. 9 as amended by Price Control Orders Nos. 30 and 46, is hereby revoked.

- Definitions and Interpretations.
  3. (1) In this Order and the Schedule thereto, unless the contrary intention appears-
- "Shark Bay area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Shark Bay;
- "Carnarvon area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Carnarvon;
- "Broome area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Broome;
- "Onslow area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Onslow;
- "Port Hedland area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Port Hedland;
- "Roebourne area" means all that area of Western Australia comprised within a radius of ten miles from the principal post office at Roebourne;
- "Derby area" means all that area of Western Australia comprised within a radius of six miles from the principal post office at Derby;

- "Yampi area" means all that area of Western Australia comprised within a radius of five miles from the principal post office at Yampi;
- "Wyndham area" means all that area of Western Australia comprised within a radius of six miles from the principal post office at Wyndham;
- "Marble Bar area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Marble Bar;
- "Nullagine area" means all that area of Western Australia comprised within a radius of twenty miles from the principal post office at Nullagine;
- "Wittenoom Gorge area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Wittenoom Gorge;
- "Noonkanbah area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Noonkanbah;
- "Fitzroy Crossing area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Fitzroy Crossing;
- "Hall's Creek area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Hall's Creek;
- "Turkey Creek area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Turkey Creek.
- (2) Where any container (such as jar, tin, packet, carton, perga or bottle) is, in the Schedule to this Order, designated by reference to its capacity (in weight or otherwise) the reference to such container shall be deemed to include a reference to other containers of the same capacity.
- (3) Reference in the Schedule to this Order to any container by means of the expression "bottle," "tin," or any similar expression, or the expression "large," "small," or any similar expression, shall be deemed to be a reference to the container customarily so described at the communication of the container customarily so described at the commencement of this Order.
