PRICES CONTROL ACT, 1948.
Prices Control Order No. 172.
Retail Price of Groceries—Northern Areas.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 172.

Revocation.

- 2. Prices Control Order No. 78 is hereby revoked.
 - Definitions and Interpretations.
- 3. (1) In this Order and the Schedule thereto, unless the contrary intention appears—
 - "Broome area" means all that area of Western
 Australia comprised within a radius of three
 miles from the principal post office at Broome;
 - "Carnarvon area" means all that area of Western
 Australia comprised within a radius of three
 miles from the principal post office at Carnarvon:
 - "Derby area" means all that area of Western
 Australia comprised within a radius of six miles
 from the principal post office at Derby;
 - "Fitzroy Crossing area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Fitzroy Crossing;
 - "Hall's Creek area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Hall's Creek;
 - "Marble Bar area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Marble Bar;
 - "Noonkanbah area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Noonkanbah;

- "'Nullagine area" means all that area of Western Australia comprised within a radius of twenty miles from the principal post office at Nullagine;
- "Onslow area" means all that area of Western
 Australia comprised within a radius of three
 miles from the principal post office at Onslow;
- "Peak Hill area" means all that area of Western
 Australia comprised within a radius of 10
 miles from the centre of the townsite of Peak
 Hill;
- "Port Hedland area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Port Hedland;
- "Roebourne area" means all that area of Western
 Australia comprised within a radius of 10 miles
 from the principal post office at Roebourne;
- "Roy Hill area" means all that area of Western Australia comprised within a radius of 10 miles from the centre of De Grey location No. 5, Roy Hill;
- "Shark Bay area" means all that area of Western
 Australia comprised within a radius of three
 miles from the principal post office at Shark
 Bay;
- "Turkey Creek area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Turkey Creek;
- "Wittenoom Gorge area" means all that area of Western Australia comprised within a radius of three miles from the principal post office at Wittenoom Gorge;
- "Wyndham area" means all that area of Western
 Australia comprised within a radius of six
 miles from the principal post office at Wyndham;
- "Yampi area" means all that area of Western Australia comprised within a radius of five miles from the principal post office at Yampi.
